# Objectives of position

- Manages the Shark Response Unit team and develops and motivates the team through coaching, mentoring and performance development/management.
- Leads the development of policies/strategies, business plans and project management plans and represents the Department at key functions and workshops.
- Provides strategic advice on emerging issues and recommends policy options for safety issues and community engagement/communication, including facilitation of a shared responsibility with stakeholder groups, and the community for risk reduction.
- Coordinates the Department of Fisheries planning, and response to shark sightings and incidents, aligned with Government policies for shark mitigation.
- Works with other agencies to improve warning notifications, systems and responses, within the scope of each agency's responsibilities.

# Key responsibilities

### **UNIT MANAGEMENT AND ADMINISTRATION**

- Coordinates the Department's Shark Response Unit, providing leadership, management and direction to the team.
- Responsible for the implementation, and evaluation of the Department's Shark Mitigation Program, including project management, and management of relevant contracts.
- Manages the Departmental response to shark sightings and incidents including communications and equipment logistics.
- Reviews and analyses budgets and expenditure.

#### **CONSULTATION AND LIAISON**

- Engages with key partners, the community, media and external stakeholders, and liaises closely with research institutions on shark hazard research programs.
- Liaises with key partners and government and private stakeholders in relation to shark tagging, shark deterrents and other shark mitigation proposals and projects.
- Undertakes community and external stakeholder consultation with respect to shark hazard management and mitigation strategies.
- Delivers high level presentations to internal and external stakeholders in relation to shark mitigation.
- Represents the Department at key functions and workshops in relation to shark hazard mitigation. Chairs meetings and workshops as required.
- Management of shark hazard communications and notification systems.

#### **POLICY AND LEGISLATION**

- Leads and manages the development and implementation of policy and legislation with respect to shark hazards.
- Prepares and supervises the preparation of reports to the Minister and the general public on shark response mitigation activities and outcomes.
- Develops communication plans and community safety policies/strategies in relation to shark hazards.
- Develops and reviews shark hazard response plans and operational arrangements for the Department.

#### OTHER

- Adheres to Departmental policies and principles in regard to equal employment opportunity, occupational safety and health and performance management systems.
- Coordination of Department of Fisheries' response to shark sightings and incidents when required.
- Project management of new shark mitigation initiatives as required.

## Work related requirements
