KEY RESPONSIBILITIES

Monitor, adjust and optimise less complex traffic control signal settings to provide a safe and efficient road network..
Participate in various technical activities relating to the operation of traffic control systems.

KEY DELIVERIES

Advanced Traffic Systems

- Monitor the operation of less complex traffic control signal settings using an advanced traffic management system i.e. the Sydney Co-ordinated Adaptive Traffic System (SCATS) and Selective Vehicle Detection (SVD) System.
- Participate in the design, implementation and optimisation of traffic signal co-ordination to improve traffic efficiency.
- Participate in the design, development and review of SCATS and SVD plans and associated traffic signal co-ordinated programs for planned and unplanned incidents that affect the road network.
- Monitor and adjust SCATS and SVD settings for designated regions.
- Participate in the development and installation of control systems for traffic signals.
- Provide technical advice and operational support to the Traffic Operations Centre.

Management Support

- Provide support with engagement and management of technical consultants and contractors.
- Provide technical support and advice to consultants and contractors in relation to traffic signal design.

Stakeholder Relationships

- Build and maintain collaborative working relationships with internal and external stakeholders.
- Provide advice to Project Managers on routine traffic signal designs and operation scenarios, including the Regions.




