- 1.2 Supervisor of Training RANZCR Radiation Oncology Training program at SCGH.
- 1.3 Development & coordination of optimal cancer care services for Western Australian patients.
- 1.4 Participate in and develop appropriate clinical trials to improve patient's outcome from cancer.
- 1.5 Participate in out of hours care of patients.
- 1.6 Participate and foster research initiatives.
- 1.7 Participate and develop departments profile in multidisciplinary management meetings.
- 1.8 Participate in departmental review, planning and teaching sessions.
- 1.9 Be actively involved in teaching of undergraduates, post graduates and allied health personnel.
- 1.10 Undertake radiation oncology service improvement projects as directed by Head of Department, e.g. implementation of VMAT, Robotic radiosurgery, IGRT, paperless environment.
- 1.11 Participate in professional development to remain current in the speciality and develop expertise in specialised areas of interest, and others as directed by Head of Department.
- 1.12 Ensures the development, implementation and maintenance of performance management systems which support the ongoing development of individual and team performance and skills.
- 1.13 Coordination of education regarding radiation oncology for medical personnel in rural areas.
- 1.14 Ensures relevant practicable occupational safety and health practices and standards are implemented and maintained.
- 1.15 Ensures the ongoing application of continuous quality improvement principles in systematically evaluating and meeting customer needs.
- 1.16 Maintain registration to the Medical Board of Australia & currency in CPD including Radiation Licences of Western Australia.

#### 2. NMHS Governance, Safety and Quality Requirements

- 2.1 Ensures, as far as practicable, the provision of a safe working environment in consultation with staff under their supervision.
- 2.2 Participates in an annual performance development review.
