- Lead operational strategies that reduce the number of people killed and seriously injured on Western Australian roads.
- Lead initiatives that strengthen safety improvements for vulnerable road users.
- Responsible for directing appropriate Congestion Program communications.

- Responsible for providing strategic leadership, expert advice and support to the Executive Director Network Operations (EDNO) for implementing functional capability improvements across the Directorate's branches.
- Responsible for promoting and demonstrating behaviours that align to Main Roads' values.

- Responsible for managing human, financial, technological, physical, and other resources in line with branch objectives,
 Main Roads' goals and objectives and government policy.

- Responsible for leading Main Roads' day-to-day involvement with the Portfolio Congestion Management Working Group and positively influencing DoT, PTA, EDs and MDs for their contribution to the development of the Congestion policy and associated integrated plan.
- Responsible for representing Main Roads and building collaborative relationships with relevant industry groups, the Transport Portfolio, partner agencies (DFES, WAPOL, SJA), Local Government and the media.
