KEY RESPONSIBILITIES

Undertake bridge inspection across the State as a member of a small Bridge Inspection Crew (BIC) in accordance with the Main Roads operational, safety and technical requirements. Collaborate with the Senior Bridge Inspection Worker (SBIW) in following all technical directions, quality systems, safety on the job, standards, procedures and guidelines.

KEY DELIVERIES

Bridge Inspection

- Undertake bridge inspection across the State as a member of a small Bridge Inspection Crew (BIC) using visual inspection, drilling and measurement techniques.
- Identify defects on bridge structures and consult with the Senior Bridge Inspection Worker (SBIW) for inclusion into inspection reports.
- Collaborate with SBIW in all aspects of bridge inspection process by following technical directions (techniques and methods of work), safety on the job, standards, procedures and guidelines.
- Operate a range of plant and equipment in the approved and safe manner and operating instructions.

Traffic Management at Worksites

- Assist in monitoring and/or implementation of temporary traffic management control devices in accordance with Traffic Management Plans (TMPs at worksites).
- Assist Senior Bridge Inspection Worker to ensure traffic management control devices at worksites are set out and maintained in accordance with approved Traffic Management Plans (TMPs) and are operating safely.

Administration and Technical Support

- Assist with the documentation of inspection findings in accordance with Main Roads reporting requirements.
- Assist with the maintenance of Maintain daily records of activities associated with bridge inspection activities.
- Assist in maintaining the inspection and other equipment in a clean condition and good working order.

On the Job Training

Participate in on-the-job training and ongoing technical development.

Safety, Health and Wellbeing (SHW)

- Carry out bridge inspections in accordance with Main Roads' Safety, Health and Wellbeing (SHW) System requirements.
- Participate in promotion of SHW awareness and 'culture' in the workplace.
- Attend and participate in daily Pre-start/Toolbox meetings before commencement of works.

Stakeholder Relationships

Develop and maintain collaborative working relationships with the BIC members.
