# **Role summary**

Ensures the effective policy development, strategic planning, regulation, monitoring, and compliance for sustainable commercial development of aquaculture in WA to maximise the economic and social benefits to the community and the State.

Manages and maintains the effective and efficient operations of the Aquaculture Management Branch. Co-ordinates input and advice to the Aquaculture Executive Committee and other Departmental aquaculture management committees. Provides the focal point for communications with the aquaculture industry and other agencies.

# About us

- Provides high level State and national leadership and representation in aquaculture management.
- Oversees and co-ordinates the management and administration of Aquaculture Management services and regulation to support industry development.
- In partnership with clients and industry development groups, identifies, plans and implements policy and initiatives for the sustainable management of Aquaculture in the State.
- Provides high level advice and briefings relating to aquaculture management
- Administers, guides and contributes to aquaculture compliance processes and supporting legislation, regulations, policy and licensing in accordance with requirements.

- Responds to referrals for inquiries or reports on matters relating to the provision of aquaculture services or industry.
- Leads and facilitates strategic aquaculture development and planning.

# Management

- Oversees and directs the effective operations, functions and administration of the Aquaculture Management Directorate.
- Reports to the Executive Director on outcomes, outputs and strategies.
- Manages the Branch's physical, financial and human resources.
- Establishes and maintains collaborative working relationships with departmental staff to meet the Department's strategic objectives.
- Provides leadership, management and development to staff to meet Branch's outcomes.
- Leads and participates in the development of emergency response capacity (e.g. people, system, infrastructure, etc.) for this function in a large-scale emergency requiring a coordinated response.
- Participates in incident and emergency management activities commensurate with capability, capacity, training and level of experience.

#### **Consultation and Liaison**

- Acts as the key point of contact between the Department and industry on aquaculture management matters, including fish health and biosecurity.
- Co-ordinates the DPIRD Aquaculture Executive Committee
- Co-ordinates other Departmental aquaculture management committees.
- Develops and maintains effective relationships and communication networks with the Aquaculture Council of WA, the peak industry representative organisation, and other key stakeholders to maximise outcomes for aquaculture.
- Represents the Department on the National Aquaculture Committee.
- Represents the Department in community education and awareness to maximise the effectiveness of the Department's programs in relation to aquaculture.
- Represents the Department in the identification, negotiation and allocation of funding for the aquaculture industry.
- Provides advice on strategic and operational matters including policy, projects, administration, resourcing and planning matters.
- Resolves complex enquiries relevant to the Branch's policy, projects and administrative activities.
- Responsible for strategic policy and planning relevant to section outcomes.
- Provides high-level input to corporate strategic planning processes.
- Other duties as required.
