MEMORANDUM OF UNDERSTANDING

SSTU TAFE EMPLOYEE RELATIONS COMMITTEE (STERC)

APPROVED QUALIFICATIONS FOR APPOINTMENT POLICY

1. PURPOSE

- 1.1 To be eligible for appointment to the Advanced Skills Lecturer (ASL) and Principal Lecturer (PL) classifications as agreed in the *Western Australian TAFE Lecturers' General Agreement 2019* (the Agreement), or its replacement, lecturers are required to have a higher education/teaching qualification.
- 1.2 This Memorandum of Understanding (MOU) lists the qualifications deemed by the Colleges and the State School Teachers' Union of WA (SSTUWA) as approved, for the purposes of eligibility to ASL classifications and PL positions and describes the process for examining any further qualification/s not contained in the **Approved Qualifications List** (Attachment 1).
- 1.3 This MOU replaces the previous version of the MOU.

2. BACKGROUND


- 2.1 The TAFE Employers and SSTUWA agree to continue the TAFE Lecturers Qualification Framework (TLQF). The parties are committed to continuing to support and encourage lecturers to achieve a lecturing qualification to a level which is an approved higher teaching qualification agreed by both parties.
- 2.2 Consistent with subclause 30.11 and Schedule M – TAFE Lecturers' Qualifications Framework of the Agreement, a higher education/training qualification is required for eligibility for appointment to ASL classifications and PL positions.
- 2.3 STERC has delegated the responsibility to assess qualifications to a STERC sub-committee established within North Metropolitan TAFE (NMT). The NMT STERC sub-committee's role is to assess each qualification and determine whether STERC ratification is required.

3. APPROVED TEACHING QUALIFICATIONS LIST


- 3.1 The qualifications listed in **Attachment 1** are approved teaching qualifications for the purposes of eligibility for appointment to ASL classifications and PL positions.
- 3.2 In the event that the SSTUWA, a College or a lecturer considers that a qualification should be included in **Attachment 1**, they should forward comprehensive details relevant to the qualification (including the certificate of completion, course outline/s and unit descriptions) to the North Metropolitan TAFE Human Resources team who will provide them to the NMT STERC sub-committee for assessment. The email for sending information is HumanResources@nmtafe.wa.edu.au.
- 3.3 The NMT STERC sub-committee will be convened on an as needs basis to consider proposed qualifications.

- 3.4 The NMT STERC sub-committee may automatically approve and ratify any qualification it assesses as being directly equivalent to a qualification included in **Attachment 1**. STERC ratification will be required where a qualification may be considered unusual or contentious.
- 3.5 If a proposed higher education qualification is not directly equivalent to a qualification included in **Attachment 1**, it will only be approved for inclusion if at least 75% of the modules/units/subjects relate directly to teaching and learning. Masters and PhD qualifications will be assessed on a case by case basis and lecturers are encouraged to submit comprehensive details of their Masters and PhD qualification if it is not listed, consistent with paragraph 3.3 above.
- 3.6 If a qualification is approved in accordance with Clause 3.5, STERC's ratification will be sought.
- 3.7 When a qualification is ratified under 3.4 or 3.6, Training Sector Labour Relations (TSLR) at the Department of Training and Workforce Development must be informed. TSLR will update **Attachment 1** and distribute it to Human Resource Managers/Directors and STERC representatives.
- 4. DISPUTE SETTLEMENT PROVISION**
- 4.1 In the event of any dispute arising from the implementation of this memorandum, an employee may access the Dispute and Grievance Resolution Procedure as prescribed by Clause 12 of the Agreement.
- 5. OVERSEAS QUALIFICATIONS**
- 5.1 With the exception of New Zealand, where a mutual recognition agreement is in place, overseas qualifications would have to be recognised through the normal channels, i.e. the Overseas Qualifications Unit.
