Role Summary

As a Senior Applications Developer within RevenueWA, this position adopts a proactive approach to develop systems and processes aimed at enhancing efficiency, exceeding stakeholder expectations, and enhancing the overall customer experience.

The primary responsibility for this role is to deliver contemporary, efficient, and effective systems and Web applications that support achieving desired outcomes by leveraging technology and streamlining processes. Additionally, this role involves overseeing the work of team members engaged in development and/or maintenance activities.

The key successes in this role involve reaching organisational goals through the enhancement of existing applications and successfully delivering new applications.

Responsibilities

- Engage in comprehensive systems delivery work including analysis, design, development, specification and implementation of IT solutions and systems to satisfy customer requirements.
- Consult and collaborate with internal and external stakeholders to discuss requirements, develop and implement IT solutions, identify performance indicators and negotiate system acceptance.
- Conduct post implementation reviews of IT solutions and systems and ensure that they meet the requirements of the Department.
- Supervise the programming, implementation, and maintenance of systems by internal and external stakeholders to ensure they are in accordance with the Department's standards.
- Provide regular updates on the progress of project work and, where necessary, represent the Department as required.
- Ensure that systems are developed according to the standards and methodologies employed by the Department.
- Demonstrate the values in all interactions to contribute towards an innovative, customer focused, high-performing and values-led organisational culture.
- Demonstrate the expected leadership behaviours and mindsets in the context of Personal Leadership.
- Perform other duties as directed.

Essential Requirements

- You will have demonstrated experience in conducting systems analysis, design, development, and implementation of information systems and web-based applications within a commercial or government environment, using an established systems development methodology.
- You possess a strong background in a JAVA application development environment, with experience in Spring Boot, Spring Security, Angular, J2EE application servers, Cloud providers on an Oracle database, as well as web technologies and source control.

- You will have strong research, analytical and problem-solving skills, with the capacity to support and contribute to the achievement of organisational goals.
- Proficient in using tools such as Eclipse, RSA, Toad, SQL Developer for Java EE, RESTful and Micro service development in technical environments like WebLogic.

Desirable Requirements

- A good understanding micro services, DevOps, Azure Pipelines, and experience with Agile project methodologies would be highly beneficial.
- Possession of or progress towards an appropriate tertiary qualification.
