Key role of this position

Core duties and responsibilities

Technical Advice and Support

- Assists staff to ensure that requirements for the support and maintenance of PTA's information and operational technology throughout their rotations.
- Provides support to Managers/Supervisors as required.
- Assists in the review and development of policies, procedures and systems.
- Investigates designated issues and recommends solutions.

Research and Administration

- Assists with investigations and implements continuous improvement actions.
- Assists with the preparation and updating of documentation, i.e. technical drawings, As built documentation and instructions.
- Undertakes research and analysis on designated projects.
- Prepares reports, briefing notes and correspondence.

Contract and Consultant Management

- Carries out designated tasks associated with the planning and implementation of works or projects relevant to the appointee's qualification.
- Assists with the establishment, administration and supervision of contracts or projects to achieve designated objectives. Monitors progress of projects or works carried out against agreed schedules and cost control and produces reports on projects or works completed.

- Satisfactory completion of required medical examinations to verify physical fitness to perform the duties of the position.
- Provision of a current National Police Clearance certificate dated 3 months or less from the date of application for the position.
- Possession of a current Western Australian 'C' or 'C-A' Class Driver's Licence or equivalent. This requirement continues for the duration of employment in this position and from time to time production of the licence on request may be required.
- Ability to work outside normal working hours, including on-site night works and weekend works.
- Applicants must successfully complete accredited rail safety training within 3 months of commencement.
 - Supervised Worker (SW) rail safety course accreditation.
