WA Country Health Service (WACHS) Additional Information - Hospital Salaried Medical Practitioners Classifications

The following pages provide a guide to the certifiable experience, skills and competencies necessary for each position classification (title) for WA Country Health Service Medical Practitioners employed as salaried medical officers as per the current Industrial Agreement.

Health Service Medical Practitioner Year 1 – 3 (South of 26° South Latitude)

Classification Description

A non-specialist medical practitioner who is not in a recognised training program and who is authorised to perform duties without requiring clinical supervision by a consultant/specialist or senior medical practitioner. This classification includes a general practitioner (not vocationally registered).

 Registered as a Medical Practitioner with the Medical Board of Australia

NB: Appointment to the position of HSMP is based on skills and experience. Minimum requirement is usually 10 years.

Senior Medical Practitioner Year 1 – 3 (South of 26° South Latitude)

A medical practitioner who does not have a recognised specialist qualification but practices without supervision exclusively in a specialist area recognised by the Australian Medical Council or such other area recognised by the Director General of Health as being a specialist area; and/or who clinically supervises other practitioners; and /or who has significant medical administration duties (50% as a guide). Promotion to Senior Medical Practitioner shall be by appointment only.

Consultant Year 1 – 9 (South of 26° South Latitude)

Classification Description

A medical practitioner who holds appropriate higher qualification of University or College, recognised by the Australian Medical Council ("the AMC"), or such other specialist qualification recognised by the Director General of Health, is employed and practising in the specialty for which he/she is qualified.

 Registered as a Medical Practitioner with the Medical Board of Australia

AND EITHER

 Fellowship of a specialist Australian Medical College or college approval for practice in an area of unmet need

OR

 Specialist qualifications and experience in the specialty for which he/she is qualified.

NB: Appointment to the position of Consultant is based on qualifications recognised by an Australian Specialty College

Classification Description

A non-specialist medical practitioner who is:

 Registered as a Medical Practitioner with the Medical Board of Australia

AND EITHER

 enrolled in a specialist training program, or is authorised to perform duties without requiring clinical supervision by a consultant/specialist or senior medical practitioner.

OR

 recognised as being equivalent to a Registrar Year 4 to Year 7 or Senior Registrar Year 1 -2 if employed in the South

NB: Formal post graduate qualifications in obstetrics or anaesthetics are considered favourably

A medical practitioner who does not have a recognised specialist qualification but practices without supervision exclusively in a specialist area recognised by the Australian Medical Council or such other area recognised by the Director General of Health as being a specialist area; and/or who clinically supervises other senior practitioners. Promotion to District Medical Officer shall be by appointment only.

 Registered as a Medical Practitioner with the Medical Board of Australia

AND EITHER

Fellowship of the Australian College of Rural and Remote Medicine (FACRRM)

OR

 Fellowship of the Royal Australian College of General Practice (FRACGP)

NB: Appointment to the position of DMO is based on skills and experience. Minimum requirement is usually 12 years in a general practice environment, or relative clinical skills and experience.

Classification Description

A medical practitioner with extensive generalist experience, able to demonstrate significant emergency department and primary health care knowledge and skills. Holds a formal qualification in anaesthetics, procedural surgery or obstetrics, or undertakes duties in such other procedural areas as are recognised by the Employer. Must be able to practice without clinical supervision in a specialist area recognised by the Australian Medical Council or such other area recognised by the Director General of Health as being a specialist area; and/or who clinically supervises other senior practitioners. Promotion to District Medical Officer (procedural) shall be by appointment only.

OR

 Specialist qualifications and experience in the specialty for which he/she is qualified.
