#### **Key Responsibilities**

Provides a clinical psychological service requiring a high level of knowledge, experience and competence within a multidisciplinary and professional team context.

Provides consultation, education, and supervision, on complex mental health/psychological disorders to both internal and external services and practitioners.

## **Brief Summary of Duties** (in order of importance)

#### 1. Clinical Services

- 1.1. Provides a clinical psychology intervention service requiring a high level of knowledge, experience, and competence with complex mental health/psychological disorders in the target patient group.
- 1.2. Provides a clinical psychology and/or neuropsychological assessment service requiring a high level of knowledge, experience, and competence with complex mental health/psychological disorders in the target patient group.
- 1.3. Contributes to multidisciplinary teams and consultancy in the service at a high level of knowledge, experience, and competence.
- 1.4. Maintains a high level of awareness of current clinical practice and research.

#### 2. Consultation, Education, Supervision, and Research

- 2.1. Provides a high level of clinical expertise at both systems and individual level relating to complex mental health/psychological disorders in one or more of the following areas:
- 2.2. Provides consultation regarding services and/or policies and procedures, with other clinical psychologists and with other professional bodies and organisations.
- 2.3. Develops new treatment protocols or assessment procedures relating to complex mental health/psychological disorders and makes these available to other health professionals.
- 2.4. Provides training and supervision at a high level for clinical psychologists and/or other health professionals.
- 2.5. Develops and implements training programs for clinical psychologists and/or other professionals.
- 2.6. Designs and implements psychological research and/or evaluation within areas of expertise.

#### 3. General Administration

- 3.1. Maintains client records and statistical data in accordance with established procedures and Directorate requirements.
- 3.2. Provides feedback and reports on training and educational activities.
- 3.3. Participates in a continuous process to monitor, evaluate, and develop performance, and participates in supervision.
- 3.4. Complies with guidelines regarding the use, maintenance and selection of psychological therapy and testing materials and other government property.

#### 4. SMHS Governance, Safety and Quality Requirements

- 4.1. Participates in the maintenance of a safe work environment.
- 4.2. Participates in an annual performance development review.
- 4.3. Supports the delivery of safe patient care and the consumers' experience including participation in continuous quality improvement activities in accordance with the requirements of the National Safety and Quality Health Service Standards and other recognised health standards.

- 4.4. Completes mandatory training (including safety and quality training) as relevant to role.

- 4.6. Abides by the WA Health Code of Conduct, Occupational Safety and Health legislation, the Disability Services Act and the Equal Opportunity Act.
- 5. Undertakes other duties as directed.

## **Work Related Requirements**

#### **Essential Selection Criteria**

- 1. Masters or Doctoral degree in Clinical Psychology and eligibility for full registration and endorsement in Clinical Psychology with the Psychology Board of Australia.
- 2. Demonstrated ability to function at a senior level and with a high degree of independence in a variety of roles such as clinician, consultant, supervisor, educator, researcher/evaluator, and agent of change in the context of a multidisciplinary team environment.
- 3. A high degree of proficiency in clinical psychology and/or neuropsychology assessment and in the development, delivery and evaluation of clinical psychology interventions with complex mental health/psychological disorders in the target patient group.
- 4. A high level of knowledge of psychological theories, models and evidence-based clinical interventions with complex mental health/psychological disorders in the target patient group.
- 5. A high level of competence in the clinical and /or neuropsychological supervision of clinical psychologists and other mental health practitioners in assessment and intervention with complex mental health/psychological disorders in the target patient group.
- 6. Demonstrated high level of organisational, communication (written and oral), and interpersonal skills.
- 7. A high level of knowledge of laws and ethical standards governing psychological research and practice.
- 8. Current knowledge and commitment to legislative obligations for Equal Opportunity, Disability Services, Occupational Safety and Health, and Quality-related activities, and how these impact on employment and service delivery.

#### **Desirable Selection Criteria**

- 1. Significant experience in providing clinical psychology assessment and intervention services for complex mental health/psychological disorders in the target patient group.
- 2. Significant experience in the delivery of community, clinic, and in-patient services.
- Board approved supervisor.
- 4. Current knowledge and commitment to Equal Opportunity in all aspects of employment and service delivery.
- 5. Current knowledge and commitment to the Carer Recognition Act 2006.
- 6. Possession of a valid 'C' or 'C.A' drivers licence.
