## **Brief Summary of Duties** (in order of importance)

#### 1. Clinical 65%

- 1.1 Co-ordinates the development, service delivery and evaluation of physiotherapy programs relating to Day Therapy Unit Clinics and Community Transition within the Rehabilitation & Aged Care Service.
- 1.2 Provides physiotherapy management of patients within the Rehabilitation and Aged Care Service.
- 1.3 Ensures the setting and maintenance of professional standards within the Team.
- 1.4 Attends program management meetings and liaises with the Health Care Team in case and program management matters.
- 1.5 Involves staff in the planning of service development and delivery.
- 1.6 Provides prophylactic and education programs for the Health Site and community.

#### 2. Professional 20%

- 2.1 Provides a positive role model, progressive leadership, guidance and clinical consultancy to physiotherapists within the team.
- 2.2 Provides the Head of Service and the Physiotherapy Head of Department with information relevant to Physiotherapy Services within the Rehabilitation & Aged Care Service.
- 2.3 Acts as a clinical consultant to other physiotherapists and health professionals within the North Metropolitan Health Service.
- 2.4 Initiates, implements and participates in research, continuous improvement and education activities.
- 2.5 Ensures that subordinate staff understands and participate in Quality Improvement, Performance Management, Professional Development and Risk Management.
- 2.6 Ensures continuing participation in own personal Professional Development and Performance Management programs.
- 2.7 Provides clinical education programs, clinical supervision and performance development for staff
- 2.8 Participates in professional organisations and establishes professional networks relevant to the Rehabilitation and Aged Care Service.
- 2.9 Responsible for investigation of incidents/accidents in work area in consultation with an OSH representative.
- 2.10 Liaises with university staff in the management of the undergraduate program, ensuring appropriate induction, supervision and assessment of students.

#### 3. Administration 10%

- 3.1 Maintains accurate clinical and statistical records and reports and ensures maintenance of such records within allocated area.
- 3.2 Reviews and up-dates policies, procedures and guidelines within the section.
- 3.3 Responsible for the orientation and training of new staff into their specific job areas, and for on-going supervision.
- 3.4 Selects equipment and supplies within allocated budget.
- 3.5 Carries out delegated Physiotherapy administrative duties.

#### 4. NMHS Governance, Safety and Quality Requirements

- 4.1 Ensures, as far as practicable, the provision of a safe working environment in consultation with staff under their supervision.
- 4.2 Participates in an annual performance development review and undertakes performance development review of staff under their supervision.
