#### **ROLE OF SECTION**

The Veterinary Department aims to provide the highest possible levels of health care, welfare, husbandry, species management and exhibit design for the animals under its care that enable Perth Zoo to achieve its operational and strategic objectives to provide a living example of natural habitats, collection planning and species management that reflect world priorities in Conservation.

# **ROLE OF POSITION**

The role of this position is to work as an effective member of the Veterinary team providing for the highest level of care, health monitoring and husbandry to a broad range of taxa in the Perth Zoo collection under moderate supervision. Proficiency is measured against procedures in a veterinary setting as required.

### **SECTION 5 - SUMMARY OF DUTIES**

### Outcome: Animal Husbandry

- 1. Undertakes the daily husbandry of animals, providing general care and monitoring. Reports any health and husbandry issues to the Supervisor or Senior Veterinarian.
- 2. Changes to animals' routines are identified, discussed and implemented.
- 3. Recognises and reports obvious sick and injured animals.
- 4. Recognises and reports basic normal and abnormal behavior.
- 5. Contributes to the development of alternative diets, diet transitions, routines and Standard Operating Procedures.
- 6. Contributes to the development of animal holding facilities to ensure they are clean and safe, and assists in enclosure refurbishment.
- 7. Implements and maintains quarantine procedures for a variety of species.

# **Outcome: Veterinary Nursing**

- 1. Captures, restrains and handles a range of animal taxa in a safe and ethical way to facilitate examination and administration of treatment.
- 2. Administers medication and monitors the condition of the animals, under supervision or direction of more senior veterinary staff.
- 3. Maintains industry standard veterinary nursing skills for all aspects of veterinary cases, including medicine, surgery, diagnostics, nutrition and implementation of treatment.
- 4. Performs a range of veterinary nursing skills on a range of species specific to a zoo environment under direction. These include but are not limited to:
  - Preparation for veterinary procedures;
  - Preparation of surgery for veterinary procedures;

- Preparation of equipment and animals for a range of veterinary procedures;
- Participates in clinical, surgical and husbandry nursing of intensive care cases;
- Anaesthesia management and monitoring;
- Responds to an animal emergency;
- Follows SOP's to set up wide range of hospital equipment; Performs in-house applied diagnostic tests.
- 5. Reports accurately, using established health care record keeping procedures including nursing notes, daily reporting and MedArks.

# Outcome: Animal Holding Maintenance & Design

- 1. Ensures that animal holding areas are suitably maintained for quarantine, sick or injured animals.
- 2. Assists in appropriate changes to enclosure environment to accommodate species for the Zoo collection and quarantine purposes, as required.

# **Outcome: Veterinary Project Management**

- 1. Contributes to project planning and veterinary management.
- 2. Contributes to animal import/export processes in conjunction with Veterinary Nursing Supervisor, veterinarians, Animal Records Officer and the Curator Collections.

## **Outcome:** Collaborative Relationships

- 1. Develops, mentors and monitors the delivery of talks, media presentations and behind the scenes tours as required.
- 2. Assists the Senior Veterinary Nurse in the development of a network of relationships with conservation partners and other professionals.
- 3. Contributes to nursing staff involvement in undergraduate veterinary training programs through course development, lecturing and practical demonstration.
- 4. Assists in the provision of training to veterinary department staff and other zoo staff to promote veterinary issues pertaining to husbandry and animal management.
- Delivers formal presentations for learning programs, workshops and conferences supporting events, public relations and education activities.

#### Outcome: Research

1. Contributes to approved research activities for the Veterinary Dept (e.g. data collection) as required in line with the Perth Zoo Research Business Plan.

# Outcome: In-situ Conservation Fieldwork

1. Contributes to approved in-situ activities for the Veterinary Dept (e.g. biological sample collection and storage, pre-release animal health checks) as required.

- 4. Assists with the coordination of Veterinary Department maintenance needs as required.
