## Job description

#### Overview of role

As an Inspector you will carry out regulatory and technical activities with limited guidance and advice, while working in a team of inspectors undertaking the enforcement of OSH legislation. You will coach and mentor less experienced colleagues as well as continuing to build your capacity to take on more senior roles.

You will also represent WorkSafe in a range of forums to meet the continuing challenge of improving safety and health in Western Australian workplaces

### Key responsibilities

As a Level 5 Inspector working as part of a team:

- Carry out workplace inspections and take enforcement action when health and safety laws are breached.
- Investigate workplace incidents and/or accidents including fatalities.
- Gather evidence, prepare prosecution reports, make recommendations about prosecutions and present evidence in court as required.
- Develop less experienced team members through coaching, advice and peer support.
- Coordinate/participate in team projects and have input to future policy/direction.
- Identify emerging issues and trends related to workplace safety and health.
- Promote OSH, deliver presentations and provide information to workplaces/organisations.
- Represent the Department in a range of committees/ working groups and forums.
- Liaise and build networks with client groups including employers, employees, government,

- unions and industry organisations.
- Take responsibility for sustaining a positive team culture.
- Undertake other duties as directed that fall within the scope of the position.

#### Inspector development:

- Complete mandatory tasks of the career progression system, to progress through to the next salary increment.
- Take reasonable care to protect their own safety and health at work, and that of others by cooperating with the safety and health policies and procedures of the department and complying with all provisions of the Occupational Safety and Health Act 1984.
