



APPLICATION REQUIREMENTS

When applying to the *Teacher Pool - Fixed Term Opportunities* or the *Graduate Teacher Pool* your application must be submitted online via JobsWA. After completing the online application questions, you must attach all documentation to your application to support your claims - if you do not, your application will be returned to you.

1. A comprehensive, up-to-date CV

Your CV must provide an overview of your experience and qualifications relevant to teaching.

2. Identification


You must provide copies of documents as proof of your identification. (Drivers' licences are not accepted)









3. Eligibility to Work in Australia







4. Teacher Registration (through the Teacher Registration Board of Western Australia)

Applicants to the **Graduate Teacher Pool**, you can submit a copy of your tax invoice from applying for your registration, a screenshot of your TRBWA Application (eForm), or your official provisional registration acknowledgement.




5. Qualifications / Academic Transcripts


