Role of Treasury

The Department of Treasury (Treasury) seeks to be highly valued as the pre-eminent economic, financial and energy policy advisor to Government and steward of the State's financial management and regulatory framework. The Department consists of the Treasury business and the Public Utilities Office (PUO).

The Treasury business provides economic and financial management and advice to Government. This includes the formulation, implementation and monitoring throughout the year of the State Budget; economic and revenue forecasting; revenue policy advice; advice and analysis on financial arrangements with the Commonwealth; advice on infrastructure policy and planning; advice on the State's financial management framework; and management of the Public Ledger.

The PUO provides quality advice on energy policy issues, including effective and efficient regulatory frameworks; security and reliability of supply; technology trends; consumer protection; and affordability.

Role Description

To develop, coordinate and deliver high quality and timely evidence based economic analysis and advice to inform government decision making. This is achieved by anticipating issues, gathering and analysing data, using logical reasoning and economic analysis to solve problems, engaging with stakeholders and implementing outcomes in a whole-of-government environment. The role will require the occupant to work both independently and as part of a larger team.

The role of Senior Analyst in the Economic Business Unit may require you to undertake a number of the following activities:

- Using and/or developing databases and new models (including spreadsheets and/or other quantitative tools) for analysis and/or forecasting.
- Leading the preparation, co-ordination and presentation of evidence-based advice on economic, financial and social issues to enable informed decision making.
- Working collaboratively with external stakeholders to understand their business, influence change and implement government policy.
- Developing an understanding of external stakeholder service delivery and the internal and external environmental drivers that impact on service delivery.
- Contributing to the achievement of deliverables consistent with the operational plan.
- Managing, supervising and/or sharing knowledge to develop other team members to achieve organisational outcomes.

In addition to the above, Senior Analysts in following divisions will focus on:

Economic and Revenue Forecasting division:

- Monitoring and analysis of economic and other data releases (eg. labour market conditions);.
- Researching, analysis and evaluation of quantitative and qualitative data to assess trends, prepare forecasts and/or provide policy advice.

Economic Policy division:

- Working with other agencies and stakeholders to identify regulatory barriers to investment and growth.
- Identifying and supporting the delivery of priority microeconomic reforms.
- Assisting agencies design risk-based and outcome focused regulation.

- **4. Displays Personal Drive and Integrity –** *Displays judgement, initiative and professionalism.* Continually develops themselves and others.
- **5. Communicates and Influences Effectively –** Communicates complex information in a clear and effective manner for the target audience.
