Project Management

- Develop project management plans in accordance with Main Roads' project management processes and procedures.
- Undertake project development activities including procurement of consultants as required.
- Manage or provide specialist technical support for managing project schedules, risks and progress reporting.
- Manage or provide specialist technical support for managing project cost estimates, budgeting, cash-flow, finances and forecasting.
- Review designs and arrange for specialist design review as required.
- Manage or provide specialist technical support for managing preconstruction activities.
- Undertake project close-out including lessons learned and reporting.

Contract Management

- Prepare procurement plans, probity plans and contract documentation.
- Manage or provide specialist technical support in managing contract tendering, evaluation and award processes.
- Develop contract management plans.
- Undertake contract management duties as delegated under the contract.
- Ensure compliance with contract requirements.
- Contribute towards improving safety in the workplace and monitor contractor's safety performance.
- Monitor progress, maintain records and prepare reports.
- Assess and recommend on claims and variations and arrange appropriate approvals.
- Review and report on contractor performance.
- Undertake contract close-out including handover and reporting.

Leadership and Resource Management

- Co-ordinate project teams, contract management teams and other resources.
- Manage financial, technological, physical and other resources within agreed allocations to meet agreed outcomes.
- Supervise employee behaviour, performance and development, where required.

Stakeholder Relationships

 Co-ordinate consultation and liaison with the community and stakeholders in relation to the development of projects and contracts.
