1. Clinical

- 1.3 To conduct Radiology review meetings with special clinical groups as rostered.
- 1.4 To attend and contribute to regular Radiology Film Review meetings in the Department and at attend various clinical meetings in other specialities relevant to their subspecialty activities in Radiology.
- 1.5 To be involved in the teaching of Radiology trainees, hospital staff and students.
- 1.6 To undertake and be involved in and promote research activities within the Radiology Department as well as in conjunction with other Clinicians as appropriate.
- 1.7 To develop areas of special interest in accordance with focus of fellowship training and expertise which is in accordance with the needs of the Department.
