Brief Summary of Duties (in order of importance)

- 1. Provides a comprehensive occupational therapy service to the Day Therapy Unit with emphasis on Falls and Memory Clinic caseload.
- 2. Determines and implements specialist assessments and intervention at an advanced level of practice to a Day Therapy Unit caseload.
- 3. Undertakes continued professional development to advance professional standards and specialist skills in rehabilitation including home visiting, gerontology especially falls, cognition, function and pressure care.
- **4.** Initiates and ensures the ongoing application of continuous quality improvement process and principles by systematically evaluating scope of practice and service direction to meet patient needs plus participate/initiates in research projects.
- **5.** Develops and delivers expert opinion and educational programmes to Occupational Therapists related to outpatient gerontology rehabilitation services especially falls and cognition.
- **6.** Provides orientation, clinical supervision and teaching to staff and students, participates in own performance management and is a role model in the Day Therapy Unit.
- **7.** Advises, consults and liaises with hospital and community agencies on clinical matters relating to specialist assessments for outpatient and community aged care patients.
- **8.** Maintains individual patient records and related demographic data within hospital and departmental guidelines.
- 9. Participates in case conferences, team and department meetings as appropriate.

10. NMHS Governance, Safety and Quality Requirements

- 3. Proven ability to develop, plan and apply specialist advanced skills in assessment and intervention techniques to Day Therapy Unit in a lean and efficient manner.
- 4. Demonstrated high level of interpersonal, verbal and written communication skills and ability to work within a multidisciplinary team and with other key stakeholders.
- 5. Commitment, participation and initiation of professional self-development, the service scope of practice, service development and evaluation , quality improvement and research for the Day Therapy Unit.
- 6. Demonstrated ability to work independently without supervision, including effective caseload management and time management skills.
- 7. Demonstrated ability to provide clinical support and supervision to relevant staff members, students and support staff.
- 8. Current knowledge of legislative obligations for Equal Opportunity, Disability Services and Occupational Safety and Health, and how these impact on employment and service delivery.

Desirable Selection Criteria

- 1. Recent experience in a gerontology outpatient caseload including assessment and intervention skills in falls, cognition or outpatient rehabilitation.
- 2. Experience in formal functional assessments.
- 3. Participation in, or completion of, relevant post graduate studies.
