Key Responsibilities: To provide a paediatric clinical service to Aboriginal children of CAHS (PCH and CACH) under the supervision of consultant paediatricians. To assist in developing the research and public health components of the CAHS Aboriginal child health program

Brief Summary of Duties (in order of importance)

1. Clinical

- 1.1 We have three registrar positions. One is a 12 month position and two are six month positions all based within the Koorliny Moort team at Perth Children's hospital.
- 1.2 Manage Aboriginal children with general medical and developmental issues at outpatient and outreach clinics under the supervision of specialists.
- 1.3 Assist with inpatient and outpatient consultation service for Aboriginal children across WA.
- 1.4 Liaise with other relevant medical, nursing and allied health staff regarding patient management and care coordination.
- 1.5 Supervise and coordinate work of junior staff and other registrars in Aboriginal child health.
- 1.6 Contribute to training and teaching of students and health professionals in Aboriginal child health.
- 1.7 Assist with Aboriginal public health program and service development.
- 1.8 Assist with Aboriginal child health research and develop own research projects.
- 1.9 Attend and actively participate in hospital and research meetings and lectures.
- 1.10 Attend general paediatric, public health, developmental and community paediatric training sessions as directed by the Koorliny Moort consultant paediatricians.
- 1.11 Perform additional duties as directed by the Koorliny Moort consultant paediatricians.
- 1.12 Participate in team meetings.
- 1.13 Participation in Department of General Paediatrics and PCH after hours and on call rosters.

2. CAHS Governance, Safety and Quality requirements

- 2.1 Responsible for ensuring, as far as practicable, the provision of a safe working environment in consultation with staff under their supervision
- 2.2 Performs duties in accordance with Government, WA Health, Child and Adolescent Health
- 2.3 Service and Departmental/ Program Specific Policies and Procedures.

Work Related Requirements

Essential Selection Criteria

1. Eligible for registration by the Medical Board of Australia.
2. Successful completion of both the written and clinical exam of the FRACP or equivalent and registration with the Royal Australasian College of Physicians as an advanced trainee in paediatrics.
3. Excellent interpersonal and communication skills including the ability to interact in a culturally sensitive manner with patients and their families, clinicians and Aboriginal health professionals within a teaching hospital setting and in the wider community .
4. A commitment to the acquisition of the knowledge, skills and attributes necessary to improve the health of Aboriginal children including an interest in and commitment to teaching these skills to other health professionals
5. Demonstrated ability to work effectively within a multidisciplinary team
6. Effective time management and organisational skills.
7. Monitors and reviews own clinical effectiveness.
8. Possession of or ability to gain a C or CA class drivers licence.

Desirable Selection Criteria

1. Current clinical experience in Aboriginal child health in a wide range of settings; general paediatrics, developmental and community paediatrics.
2. Evidence of interest in research within the field of paediatrics.
3. Current knowledge of legislative obligations for Equal Opportunity, Disability Services and Occupational Safety and Health, and how these impact on employment and service.

Appointment Prerequisites

Appointment is subject to:

- Evidence of registration by the Medical Board of Australia must be provided prior to commencement.
- Working With Children (WWC) Check, compulsory check for people who carry out child-related work in Western Australia.
- Evidence of a current C or CA class drivers licence must be provided prior to commencement.
- Completion of 100 point identification check
- Successful Criminal Record Screening Clearance
- Successful Pre-Employment Integrity check
- Successful Pre-Employment Health Assessment
