1. Specific Duties/Scope of Practice Relevant to Speciality

- 1.1 Works in accordance with the Mental Health Act 2014 and other relevant legislation.
- 1.2 Works in partnership with consumers and their carers to deliver consumer focused, recovery oriented care.
- 1.3 Works in a manner that assists consumers to recognise and build on their strengths whilst providing care consistent with trauma informed principles.

2. Clinical

- 1.1. Assists the Registered Nurse in giving direct care to a group of patients.
- 1.2. Application of nursing process when undertaking patient care.
- 1.3. Maintains a high level of communication and interpersonal skills.
- 1.4. Participates in mental health promotion and education programs for patients, families and carers.
- 1.5. Promotes and maintains continuity of care by ensuring comprehensive iSoft ISOBAR handover of responsibilities to oncoming staff.
- 1.6. Applies clinical knowledge and skills to ensure safe nursing practice and a safe environment for patients, relatives, visitors and staff.
- 1.7. Acts as a patient advocate.
- 1.8. Participates in emergency procedures.
- 1.9. Ensures that clinical documentation recorded is comprehensive, objective and accurate and undertakes administrative tasks as required.
- 1.10. Participates in interdisciplinary decision matters pertaining to patient care.
- 1.11. Liaises with Senior Nursing personnel on clinical issues not within his/her scope of authority.
- 1.12. Participates in team building, decision making and other meetings as required.
- 1.13. Undertakes clinical shifts at the direction of senior nurses and the Nurse Director including participation in the after-hours and weekend roster.
- 1.14. Collects and records statistical data as required by the service.
- 1.15. Liaises with the Nurse Manager and Clinical Nurse Specialist regarding the replacement or need for equipment and supplies.

- 3.1. Engages in continuing professional development / education and accepts responsibility for competency development of self, including the area of Forensic Mental Health Nursing.
- 3.2. Responsible for maintaining own professional standards of practice and developing competency in the area of Forensic Mental Health Nursing.

- 3.4. Educates and orientates other staff members within the scope of practice.
