Brief Summary of Duties (in order of importance)

1. Clinical Responsibilities

1.1 Provide clinical education, assessment and supervision to allocated physiotherapy students from Curtin University

1.2 Provide tutorials and other teaching activities that support student learning in the Neurology Outpatient setting.

1.3 Liaises with the Clinical Coordinator at Curtin University/Notre Dame University on all aspects of clinical education in the Neurology outpatient setting at SCGH

1.4 Provides specialist Physiotherapy services in the Neurology Outpatient setting through comprehensive patient screening and assessment, intervention and case management using advanced clinical practice and interdisciplinary skills.

1.5 Implements and maintains performance management systems which support the ongoing development of individual and team performance.

1.6 Maintains patient records, including preparation of progress and final reports and maintains treatment statistics and related documentation.

1.7 Participates in a weekend inpatient roster as requested.

1.8 Ensures the ongoing application of continuous quality improvement principles in systematically evaluating and meeting customer needs.

1.9 Participates in a weekend inpatient roster as requested.

2. Professional Development Training

- 2.1 Assists in the planning and provision of ongoing professional development for the Neurosciences team as requested.
- 2.2 Undertakes continuing professional development to advance professional standards and specialist skills in the neurology setting, including training in interdisciplinary interventions relevant to the area.

3. Representation

3.1 Participates in team and department meetings.

- 3. Demonstrated ability to work effectively within a multi-disciplinary and interdisciplinary team.
- 4. Demonstrated high level of interpersonal, verbal and written communication skills.
- 5. Demonstrated planning and organisational ability.
- 6. Experience in initiating and coordinating quality improvement and/or research activities.
- 7. Demonstrated commitment to, and involvement in ongoing professional development.
- 8. Knowledge of occupational safety and health principles including maintaining a Duty of Care.
- 9. Proven ability to supervise and conduct in-service training to staff and students.
