1.0	CLINICAL		70
1.1	Provides general medical specialist services, including community-based, outpatient and inpatient services within the Goldfields Region based at Kalgoorlie Health Campus, in liaison with the other medical practitioners and where appropriate, Aboriginal Medical Services.		
1.2	Participates in the after hours, weekend and public holiday on-call roster in association with the other medical practitioners.		
1.3	Supports Aboriginal Health Workers, allied health staff, hospital and community nurses in delivering appropriate clinical services.		
1.4	Manages medical conditions according to acceptable clinical standards.		
1.5	Collaborates with Medical ward and Special Care Unit Clinical Nurse Specialist and Nursing staff to facilitate patient management. Liaises with patients, family, community services and other representatives as required to facilitate patient management.		
1.6	Supervises, mentors and educates Doctors in Training and Senior Medical Officers who are providing clinical care to Medical patients.		
1.7	Liaises with other senior medical staff in Kalgoorlie and elsewhere, with allied health staff and with hospital managers to facilitate a high standard of patient care. Negotiates with patient transport providers such as the Royal Flying Doctor Service and St John Ambulance to facilitate transfer of patients for tertiary care.		
1.8	Works with colleagues and counterparts in the Goldfield Region to develop an integrated specialist general medical service in the region.		
1.9	Reports notifiable diseases promptly (to local regional and state authorities).		
1.10	Develops and provides an integrated WA Country Health Service (WACHS) Goldfields regional general medicine service including the provision of telephone and videoconference consultation and advice. Service provision will need to be flexible and may vary from time to time depending on organisational needs and objectives.		
2.0	CLINICAL ADMINISTRATION		10
2.1	Promotes clinical governance and clinical risk management within the Medical Department.		
2.2	In collaboration with other Physicians and the Medical nursing staff, actively participates in the management of the Medical Department including equipment choice, staffing proposals and workplace redesign. Undertakes performance management of subordinate staff.		
2.3	Prepares and conducts professional reports, reviews and other requests pertaining to patients.		
2.4	Participates in the development and implementation of evidence-based policies in adult health care which are relevant in the hospital and community setting and to the region.
