Role of Treasury

Treasury is the central department managing Western Australia's public sector finances and formulating and implementing the annual State Budget. Treasury develops economic and revenue forecasts, monitors developments in the State's economy, major revenue bases and public sector finances, to ensure Western Australia remains on track against the State Government's budgetary objectives and targets. Treasury's policy advisory role covers a wide range of issues, including Commonwealth State financial relations, revenue policy, public sector wages policy, public sector superannuation policy, and advice on alternative models of service delivery and infrastructure provision.

Role Description

As a Vacation Program Intern in a central government agency, you will support Government decision making by providing economic and financial policy advice on a range of complex issues. You will work within a small team and will have the opportunity to liaise with other areas of Treasury, as well as other public sector agencies and private sector stakeholders. You will undertake research, assist in providing timely clear and evidenced-based policy analysis, and undertake project work as required.
