- Provide strategic subject matter expertise (SME) for the selection, delivery, management and improvement of architecture frameworks and associated technologies.
- Provide SME and input to the strategic direction of technology investments to ensure suitable development of Main Roads' enterprise architecture and maximise the return on technology investment.
- Manage the establishment, implementation and maintenance of corporate ICT policies, standards and procedures.
- Lead strategic discussions with business and technical stakeholders, promote the potential of digital technologies and associated possibilities in response to business needs.
- Manage all statutory, regulatory, whole of government and organisational ICT security policy requirements to ensure the requirements are followed, understood, documented, disseminated and appropriately implemented.
- Provide strategic advice to the Chief Information Officer (CIO) and senior business stakeholders on enterprise architecture matters and issues.
- Manage ICT capability in providing functional expertise and a technical understanding of specialised business systems, and the related implication of digital technologies.
- Ensures integration and communication between the Enterprise Architecture Office (EAO) and other areas within the Information Management Branch (IMB).

Leadership and Management

- Lead the delivery of ICT Strategic Planning and Main Roads' Enterprise Architecture capability.
- Provide strategic and operational leadership to ensure establishment, implementations and review of Enterprise Architecture framework
- Manage the formulation and delivery of the Branch Business Plan.
- Manage financial, technological, physical and other resources within agreed allocation to meet agreed outcomes.
- Manage employee behaviour, performance and development.

Stakeholder Relationships

- Negotiate, consult and liaise with Government agencies, commercial enterprise and senior management on the availability and suitability of enterprise architecture systems and ICT technologies.
- Participate as a member of internal and external committees in order to represent the Branch, Directorate and Main Roads relating to enterprise architecture and ICT security.
