ROLE SCOPE

The Production Manager North is responsible for the planning and implementation of integrated harvesting operations for the Forest Products Commission (FPC) in the northern division of the Southwest area. The role implements and achieves the annual harvesting works programs and coordinates the distribution of log sales to contracted buyers. The role also monitors environmental impacts, follows appropriate procedures and ensures that standards of prevention and correction are met, and specifications are applied. This position is also responsible for ensuring budgeting and expenditure requirements are effectively managed, monitored and reported.

DUTIES AND RESPONSIBILITIES

1. Shapes and manages strategy

- Understands the FPC's objectives and aligns operational activities accordingly.
- Provides leadership and direction in planned operational activities within the Northern Supply Zone across softwood, hardwood and sandalwood operations.
- Contributes to the preparation, effective management and monitoring of annual budgets and targets to guide the branch in achieving its goals.
- In conjunction with the FPC Forest Management and Strategic Planning Branches, participates in the development of the annual, three-year and five-year harvest plans.
- Contributes to the continuous review and development of forestry management standards and procedures.
- Liaises closely with the New Business and Innovation Branch to seek and develop opportunities for log sales, within or outside the existing customer base, to optimise utilisation of forest products from the FPCs operations.
- Leads innovation and creative thinking and solutions within an environment of transparency and accountability.

2. Achieves results

- Accountable for achieving a high uniform standard of practice in accordance with the FPC, Department of Biodiversity, Conservation and Attractions (DBCA) and Forest Industry policy, procedures, guidelines, codes and manuals.
- Effectively and efficiently manages the execution of "Contracts of Sale" and "Contracts of Supply" to meet annual delivery targets, silvicultural requirements and environmental compliance.
- Can respond in a positive, flexible and transparent manner to changes to supply, demand or resource availability.
- Implements best practice supply chain principles in integrated forest harvesting and log transport within the framework of the Forest Management Plan, relevant Legislative requirements and the FPC's strategic objectives.
