- Prepares and coordinates reports, submissions, briefings, correspondence and advice of major regional projects and proposals to the executive management team and the Board, also draft Ministerial and Executive correspondence as required.
- Provides analysis and due diligence assessments on business cases and economic development projects undertaken in the region, develop relevant evaluation methodology and provide professional advice and solutions to address issues that will affect performance indicators and/or milestones.
- Facilitates the development and implementation of industry and business strategies and plans, in partnership with relevant government agencies and private sector, to ensure the development and implementation of complex project outcomes.
- Develops and facilitates projects that enhance the development of the region, including community development, economic diversification, land, accommodation, infrastructure to also increase local employment through the growth and development of local business.
- Prepares and undertakes the research, development and compilation of project plans including investigations, feasibility studies, tender processes and project costs.
- Coordinates the management and implementation of project plans to achieve the implementation of outcomes detailed in the Commission's Strategic Plan including the prioritising and allocation of resources and the delivery of outcomes within agreed parameters, e.g. time, cost, quality.
- Conducts research, analysis, due diligence, input, updates and reports for current and new or potential regional grant programs.
- Mentors, coaches and support all staff across the Region as required.
- Contributes to the preparation of advice to the Board.

Client and Stakeholder Engagement

- Monitors consultants and contractors to ensure government objectives and deliverables are met efficiently and effectively.
- Works collaboratively with Communications and other relevant Corporate areas to promote regional development projects, publicly address specific issues and providing promotional and other information to the public.
- Prepares and directs staff in the preparation of submissions and responses to ministerial, parliamentary questions and briefing notes.
- Liaises with Commonwealth, State and Local Government, community bodies and industry sector groups on matters related to the region.
- Proactively builds and manages strategic partnerships and communication networks with internal and external clients and stakeholders to ensure that regional development issues and projects are dealt with in a coordinated and integrated manner.
- Represents the Commission at industry forums, committees and working groups as required and organises and conducts meetings.
- Maintains and manages a network of contacts and strong collaborative relationships across regional communities, business and industry, relevant Federal, State and Local Government agencies, prospective investors and trade partners to pursue investment opportunities.
