# **Brief Summary of Duties (in order of importance)**

#### **SCOPE OF THIS POSITION**

The position of Technical Officer (Orthotics & Prosthetics) works within a team responsible for manufacturing, adaptation, service and maintenance support in relation to the provision, operation, safety and serviceability of orthotic and prosthetic appliances provided to patients through Rehabilitation Technology Unit (RTU), to State Rehabilitation Services and to related hospitals and community based services (CAEP) provided to the SMHS and the State.

#### 1. The position is responsible to the Senior Orthotist / Senior Prosthetist to:

- 1.1 Provide construction, maintenance, repair, quality assurance and performance testing on specialised orthotic and interim prosthetic appliances provided directly to patients and clients of the Orthotics and Prosthetic Service. It is expected that the position will be trained across relevant areas of specialisation with the Service, in order to develop a broad and comprehensive range of skills and competencies.
- 1.2 Provide advice, training and assist Hospital clinical, allied health and other staff in relation to the operational and safety aspects of equipment and appliances falling within the scope of the position.
- 1.3 Ensure the entry of accurate information into the relevant databases in order to comply with quality assurance requirements and to provide a comprehensive record of services provided in respect of disability equipment and service provision, accurately reflecting the use of labour, parts and consumables.
- 1.1 Manage personal work flow to ensure timely compliance with the requirements of the Division's quality management objectives; viz: (i) maintenance and updating of current, accurate, and complete quality documentation reflecting the continuous improvement of work practices; (ii) facilitation of the conduct of internal review and the timely implementation of agreed initiatives.
- 1.2 Maintain appropriate contemporary knowledge of (i) rehabilitation practices, measurement and fitting techniques relevant to the provision of orthotic appliances (including spinal bracing) and interim prosthetic appliances provided for adult amputee rehabilitation (ii) safety aspects of providing orthotic and prosthetic appliances to be used in the community (iii) advanced manufacturing techniques (iv) bacterial contamination, infection control and other hazards as identified of advised.
- 1.3 Ensure at a personal level that relevant occupational safety and health practices and standards are implemented and maintained.
- 1.4 Design, construct or modify specialised orthotic and prosthetic equipment as directed.
- 1.5 Observe protocols supporting the operation and maintenance of the Division's imprest stores.
- 1.6 Provide the Supervising Technician and colleagues with information and the access necessary for maintaining reliable and timely communication at all times, while working in the hospital or on related activities.
- 1.7 Other duties as reasonably directed by the Senior Orthotist/Senior Prosthetist/Supervising Technical Officer.

#### 2. The post is responsible to service recipients to

- 2.1 Ensure delivery of services within the set time frame at an acceptable quality, in accord with priorities developed in liaison with the Supervising Technical Officer.
- 2.2 Ensure an efficient, effective, timely, and ongoing process of continuous quality improvement, consultation and feedback to customers in order to meet their needs and concerns.

#### 2. EMHS Governance, Safety and Quality Requirements

- 2.1 Participates in the maintenance of a safe work environment.
- 2.2 Participates in an annual performance development review.
- 2.3 Supports the delivery of safe patient care and the consumers' experience including participation in continuous quality improvement activities in accordance with the requirements of the National Safety and Quality Health Service Standards and other recognised health standards.
- 2.4 Completes mandatory training (including safety and quality training) as relevant to role.
- 2.5 Performs duties in accordance with Government, WA Health, East Metropolitan Health Service and Departmental / Program specific policies and procedures.
- 2.6 Abides by the WA Health Code of Conduct, Occupational Safety and Health legislation, the Disability Services Act and the Equal Opportunity Act.

- Knowledge and understanding of the general principles of Continuous Quality Improvement and their practical application in systematically evaluating and meeting customers' needs. Direct practical participation in an accredited Quality Management System such a ISO9001
- 4. Current knowledge and commitment to Equal Opportunity in all aspects of employment and service delivery.
