Prime Function / Key Responsibilities

Assessment, diagnosis and management of patients with sleep disorders.

Maintenance of a sleep disorders service.

Consultant – Physician - Respiratory and Sleep Medicine | Year 1-9 | 006681 Brief Summary of Duties (in order of importance)

- 1. Assessment, diagnosis and treatment of patients with disordered breathing during sleep and related disorders such as narcolepsy, movement disorders during sleep and parasomnias. Assessment and management of associated respiratory diseases in such patients.
- 2. Reporting on routine lung function testing and overnight sleep studies of both outpatients and inpatients.
- 3. Care of inpatients including those requiring assisted ventilation with nasal continuous positive airways pressure or intermittent positive pressure ventilation.
- 4. Providing medical reports and undertaking other management tasks as appropriate.
- 5. Supervision of junior medical, scientific, and (where appropriate) nursing, allied health and other support staff including assessment of staff performance in relation to clinical competence, adherence to departmental protocols, timely and accurate documentation, communication with patients, relatives, peers, other staff and doctors in other hospitals and in the community.
- 6. Participation in professional continuing educational activities regular performance review and a commitment to maintain and update own knowledge skills.
- 7. Participation in postgraduate training programs and in teaching programs for junior medical, scientific, nursing, allied health and other support staff and undergraduate medical students.
- 8. Participation in clinical and/or fundamental research and active promotion or research activities wherever possible. This may include: planning, initiating and supervising continuing programs of research related to respiratory and/or sleep disorders; and supervision of PhD students and senior research assistants.
- 9. Participation in activities of professional groups and societies in the areas of respiratory and sleep disorders medicine and research.
- 10. Assisting achievement of departmental and organisational objectives in a feasible and innovative manner. This may include: participating in departmental and other meetings; developing appropriate strategic plans and procedures for effective and cost-effective use of department resources; and liaising with other hospital staff and professional organisations.
- 11. Ensuring the ongoing application of continuous quality improvement principles in systematically evaluating and meeting customer needs.
- 12. Commitment to the highest ethical and professional standards.
- 13. Commitment to implementation and maintenance of relevant, practicable occupational safety and health practices and standards.

- 4. Good communication and interpersonal skills.
- 5. Effective participation and leadership in a multi-disciplinary team.
- 6. Demonstrated interest and expertise in teaching, both graduates and undergraduate and research.
- 7. Knowledge and understanding of continuous quality improvement principles and their practical application.
- 8. Knowledge of contemporary human resource management principles including Employment Equity.
- 9. Knowledge of occupational safety and health principles including maintain a Duty of Care.
- 10. Current knowledge of legislative obligations for Equal Opportunity, Disability Services and Occupational Safety and Health, and how these impact on employment and service delivery.

Desirable Selection Criteria

- 1. A postgraduate degree e.g. MSc, MD, PhD, in an area of clinical science relevant to the appointment.
- 2. Background in clinical and scientific research. Demonstrated commitment to research and higher postgraduate qualifications supporting this.
