Prime Function / Key Responsibilities

Responsible for the provision and maintenance of mammography screening services at metropolitan sites and/or country mobile clinics and/or Bunbury clinic.

Brief Summary of Duties (in order of importance)

1. Ensure that the welfare, privacy and security of the patient during examination are maintained.
2. Produce mammograms of maximum diagnostic value in accordance with radiation health standards.
3. Provide information and support to women on the mammography screening and assessment pathway.
4. Accurately record all significant information in relation to the examination.
5. Ensure the accurate identification of images.
6. Ensure the correct archiving and transfer of images to PACS, CD or printer as required to comply with BSWA policy and procedures.
7. Perform quality assurance tests on mammographic equipment to comply with BSWA policies and procedures.
8. Ensure that adequate supplies of radiographic and related material are kept in stock at the screening unit at all times.
9. Comply with Occupational Safety Health instructions in accordance with BSWA policies and procedures.
10. Perform reception duties in the mammography Screening Services units as required.
11. Ensure the emergency repair of all mammographic imaging and related equipment, record equipment faults and the necessity for emergency maintenance in the maintenance log and report these matters to the Senior Medical Imaging Technologist.
12. Participate in training courses for radiographers performing mammography as an integral member of the breast screening team.
13. Participate in the on-the-job training and induction of the screening service staff.
14. Participates in quality improvement activities as required.
15. Works across various health sites as required
16. Maintain an awareness of relevant requirements related to:
 - equal opportunity;
 - disability access; and
 - clinical and corporate governanceand apply these in the workplace.
