### Key Responsibility

The primary role of the Senior Registrar – Neonatal and Infant Retrieval (NETS), is to provide comprehensive diagnostic assessment and advanced clinical skills during neonatal and infant retrieval intrastate and interstate. The Retrieval Senior Registrar will have a team approach to provide safe, effective and well organised care and transport of patients in collaboration with medical, nursing and allied health professionals.



## About our health service

The Child and Adolescent Health Service (CAHS) is a comprehensive service that supports and treats children from around Western Australia, and is committed to programs that promote lifelong health in children and adolescents.

### CAHS is made up of three service streams:

- **Community Health:** a comprehensive range of community based early identification and intervention services, as well as health promotion, to children and families in the Perth metropolitan area. Services are provided in a variety of settings including at home, local community health centres, child and parent centres and schools.
- **Child and Adolescent Mental Health Services (CAMHS):** provide mental health services to infants, children, young people and their families across the Perth metropolitan area. Services include community based programs, inpatient care at Perth Children's Hospital and specialised services for children with complex mental health conditions across the State.
- **Perth Children's Hospital (PCH):** is the specialist State-wide paediatric hospital and trauma centre for Western Australia, caring for children up to the age of 16. PCH is also a centre of excellence for teaching and research, partnering in major paediatric research and education initiatives led by the Telethon Kids Institute (TKI) and the State's universities.

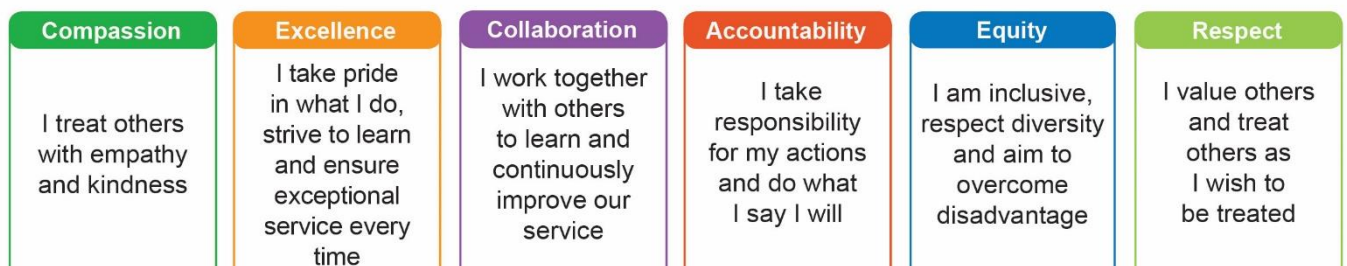
Our vision of 'healthy kids, healthy communities' sees that children and young people get the best start in life through health promotion, early identification and intervention and patient centred, family-focused care.

## Summary of accountabilities

### Brief Summary of Duties (in order of importance)

- Provide comprehensive diagnostic assessment and advanced clinical skills during neonatal retrieval from metropolitan, intrastate regional and interstate centres.
- Participates in the transport of patients from metropolitan, intrastate regional and interstate as required for the provision of safe patient care.
- Participate in triage and stabilisation advice processes, in consultation with NETS WA Neonatal Consultant.
- Co-ordinate and record NETS referrals through a dedicated call conference system and written documentation.
- Participating with medical and nursing team members in the preparation and maintenance of retrieval equipment
- Participating in daily case review meetings through reviewing team management and patient outcomes and case presentations.
- Development and implementation of research, audit and quality improvement projects.
- Lead and participate in multidisciplinary training and education activities.
- Promotes a multi-disciplinary approach to decision making to ensure a high standard of care that is effective, safe and efficient.
- Ensuring the receiving unit medical and nursing staff have appropriate handover of the clinical status of the patient and the expected arrival time
- To collect, evaluate and present information on neonatal morbidity and mortality in relation to NETS WA.

CAHS governance, integrity, safety and quality requirements

### Work related requirements

#### Essential selection criteria

1. Eligible for registration by the Medical Board of Australia
2. Minimum of 6 months Australian NICU level 3 experience
3. Demonstrated expert level of knowledge and advanced skills in neonatal intensive care including neonatal transport and retrieval.
4. Demonstrated highly developed analytical, conceptual and problem solving.
5. Demonstrated advanced skills in verbal and written communication, negotiation and interpersonal skills
6. Demonstrated ability to lead and work effectively as part of a multi-disciplinary team
7. Demonstrated experience in clinical teaching, audit and clinical research.

#### Desirable selection criteria

1. Evidence of successful completion (a minimum of 7 in all bands) of the English Language Skills (IELTS) Academic Level or equivalent for overseas applicants who did not complete their secondary education in English.
2. Part I of the Fellowship of the Royal Australasian College of Physicians, or equivalent specialist qualification.
3. Current knowledge and commitment to Equal Opportunity in all aspects of employment and service delivery.
4. Current and valid driver's Licence.

#### Appointment to this position is subject to the following:

- Evidence of registration by the Medical Board of Australia must be provided prior to commencement.
- Working with Children (WWC) Check, compulsory check for people who carry out child-related work in Western Australia.
- Evidence of current and valid driver's licence
- Provision of the minimum identity proofing requirements in line with the standards set by the National Security Strategy.
- Successful criminal record screening clearance.
- Successful pre-employment integrity check.
