## Brief Summary of Duties (in order of importance)

- 1. Specific Duties/Scope of Practice Relevant to Specialty**
  - 1.1 Ensures the smooth day to day running of the Specialist O & G clinic e.g. Obtaining results, maintaining clinical registers and data bases, stores, TGA and pharmacy orders.
  - 1.2 Provide clinical support to other clinic nurses and consultants.
  - 1.3 Chaperone and assist consultants with procedures, patient education, specimen collection, theatre bookings and clinical paperwork.
  
- 2. Clinical**
  - 2.1 Provides comprehensive evidence based nursing care to patients including assessment, intervention and evaluation.
  - 2.2 Undertakes clinical shifts at the direction of senior staff and the Nursing Director including participation on the on-call/after- hours/weekend roster if required.
  - 2.3 Supports and liaises with patients, carers, colleagues, medical, nursing, allied health, support staff, external agencies and the private sector to provide coordinated multidisciplinary care.
  - 2.4 Completes clinical documentation and undertakes other administrative tasks as required.
  - 2.5 Participates in departmental and other meetings as required to meet organisational and service objectives.
  - 2.6 Participates in quality improvement and policy review/development within the practice setting.
  - 2.7 Complies with and demonstrates a positive commitment to Regulations, Acts and Policies relevant to nursing including the Code of Ethics for Nurses in Australia, the Code of Conduct for Nurses in Australia, the National Competency Standards for the Registered Nurse and the Poisons Act 1964.
  - 2.8 Promotes and participates in team building and decision making.
  - 2.9 Responsible where applicable for the clinical supervision of Enrolled Nurses/Assistants in Nursing under their supervision.
  
- 3. Education/Training/Research**
  - 3.1 Engages in continuing professional development/education and ensures continuous registration in the category of Registered Nurse with the Nursing and Midwifery Board of Australia as per essential criterion 1.
  - 3.2 Participates in supervision, professional development and clinical consultation activities with the supervising senior nurse.
  - 3.3 Assists with supervision and development of undergraduate nursing students and others as directed by senior staff.
  - 3.4 Plans, develops and implements education programs for patients/colleagues/consumers.
  - 3.5 Participates in evidence based clinical research activities where applicable.

**4. EMHS Governance, Safety and Quality Requirements**

- 4.1 Ensures, as far as practicable, the provision of a safe working environment in consultation with staff under their supervision.
- 4.2 Actively participates in the Peak Performance program.
- 4.3 Supports the delivery of safe patient care and the consumers' experience including identifying, facilitating and participating in continuous safety and quality improvement activities, and ensuring services and practices align with the requirements of the National Safety and Quality Health Service Standards and other recognised health standards.
- 4.4 Adheres to the performance framework for procurement and contract management and oversees and promotes to other staff this process and function in accordance with EMHS Policy and the Delegations and Authorisations Schedule.

## Work Related Requirements

### Essential Selection Criteria

1. Eligible for registration in the category of Registered Nurse by the Nursing and Midwifery Board of Australia.
2. Demonstrated clinical knowledge and experience in the delivery of evidence based nursing care within the practice setting/specialty.
3. Demonstrated effective interpersonal, negotiation and conflict resolution skills.
4. Demonstrated effective written and verbal communication skills.
5. Knowledge and experience in the Quality Improvement Cycle and patient safety initiatives.
6. Current knowledge of legislative obligations for Equal Opportunity, Disability Services and Occupational Safety and Health, and how these impact on employment and service delivery.

### Desirable Selection Criteria

1. Knowledge of current clinical governance systems.
2. Knowledge of gynaecological conditions and procedures.

### Appointment Prerequisites

Appointment is subject to:

- Evidence of current registration by Nursing and Midwifery Board of Australia (supported by AHPRA) must be provided prior to commencement.
- Working With Children (WWC) Check, compulsory check for people who carry out child-related work in Western Australia.
- Completion of 100 Point Identification Check.
- Successful Criminal Record Screening Clearance.
- Successful Pre-Employment Integrity Check.
- Successful Pre-Employment Health Assessment.
