Key Responsibility

As part of a multidisciplinary team provides specialist oncology, haematology and precision medicine services to patients. Promotes patient quality and safety and provides leadership, training, supervision and education, where relevant, for doctors in training and other health workers in collaboration with other Consultants and the Clinical Director/Head of Department. Works within the scope of clinical practice as defined by the Health Service Credentialing Committee.

About our health service

The Child and Adolescent Health Service (CAHS) is a comprehensive service that supports and treats children from around Western Australia, and is committed to programs that promote lifelong health in children and adolescents.

CAHS is made up of four service streams:

• **Neonatology:** Neonatology provides state-wide tertiary neonatal services to the sickest newborn babies and infants in Western Australia.

• **Community Health:** a comprehensive range of community based early identification and intervention services, as well as health promotion, to children and families in the Perth metropolitan area. Services are provided in a variety of settings including at home, local community health centres, child and parent centres and schools.

• Child and Adolescent Mental Health Services (CAMHS): provide mental health services to infants, children, young people and their families across the Perth metropolitan area. Services include community based programs, inpatient care at Perth Children's Hospital and specialised services for children with complex mental health conditions across the State.

• **Perth Children's Hospital (PCH):** is the specialist State-wide paediatric hospital and trauma centre for Western Australia, caring for children up to the age of 16. PCH is also a centre of excellence for teaching and research, partnering in major paediatric research and education initiatives led by the Telethon Kids Institute (TKI) and the State's universities.

Summary of accountabilities

- 1. Clinical
- Provides specialist oncology/ haematology /bone marrow transplant services to patients within the Department and provides a consultation service on request for other patients.
- Provides specialist personalised medicine input and works closely with Zero Childhood Cancer and Personalised Medicine Groups and Teams
- Undertakes clinical shifts in the Department at the direction of the Clinical Director/Head of Department including participation on the on-call/afterhours/weekend roster.
- Accepts appropriate referrals from doctors external and internal to PCH.
- Takes a leadership and mentoring role for doctors in training and others within the Department.
- Clinically reviews or assess patients within 24 hours of admission when on-call or admitted under their care.
- Conducts regular clinical review of patients at appropriate intervals with doctors in training with a focus on discharge planning, ensuring that the medical record (including discharge summaries) is accurately up dated after review of each patient.
- Conducts clinical review and clinical management of patients referred to outpatient services.
- Support and liaises with patients, carers, colleagues, nursing, allied health, support staff, external agencies and the private sector to provide coordinated multidisciplinary care.
- Provides medical reports and undertakes other administrative/management tasks as required.
- Participates in departmental and other meetings as required to meet organisational and service objectives.
- Participates in relevant clinical governance committees including regular clinical reviews, Root Cause Analysis (RCA) and morbidity/mortality reviews as required.
- Attends to medico legal issues that arise concerning patients that have been under their care and advises the Head of Department about complaints they receive pertaining to themselves or other doctors.

2. Education/Training/Research

- Engages in continuing professional development/education and ensures continuous eligibility for relevant specialist medical registration.
- Participates in regular peer review and case review meetings.
- Develops and participates in clinical research activities relevant to speciality.
- Participates and assists in the continued medical educational activities of medical students, doctors in training, non-specialist medical officers, visiting medical practitioners, nurses and other health workers (including formal presentations and/or tutorials as required).

3. CAHS Duties

• Responsible for ensuring, as far as practicable, the provision of a safe working environment in consultation with staff under their supervision.

- Performs duties in accordance with Government, WA Health, Child and Adolescent Health Service and Departmental/ Program Specific Policies and Procedures.
- Performs duties in line with the National Safety and Quality Health Services Standards and within best practice.
- Participates in a continual process to monitor, evaluate and improve patient safety and ensuring that services are family centred.

- 3. Demonstrated experience and expertise in precision oncology
- 4. Demonstrated ability to provide clinical leadership and facilitate effective patient centred care in a complex multidisciplinary team environment.
- 5. Demonstrated substantial clinical experience in the field of Paediatric Oncology, Haematology and/or Bone Marrow Transplant and in the management of these patients in a complex hospital environment.
- 6. Demonstrated ability to implement sustainable change to improve patient safety and reduce unnecessary delays in patient management.
- 7. Demonstrated experience and commitment to clinical teaching and clinical research.
- 8. Demonstrated excellent interpersonal, communication, negotiation and conflict resolution skills with an ability to liaise effectively with patients, individuals and the multidisciplinary team.
- Current knowledge of legislative obligations for Equal Opportunity, Disability Services and Occupational Safety and Health, and how these impact on employment and service delivery.

1. Demonstrated clinical/research expertise in a subspecialty of Paediatric Oncology, Haematology and/or Bone Marrow Transplant.
