You will be responsible for promoting and developing a visible presence of music within our school community including opportunities such as music assemblies and performances. It would also be highly desirable for the successful applicant to have experience in teaching ukulele, drum notation and composition. The Music Specialist will also coordinate the instrumental music program in the school on behalf of "The School for Instrumental Music".

Bicton PS is located in the established suburb of Bicton, 6km east of Fremantle, near the beautiful Swan River. The school was opened in 1904. As an independent public school, Bicton Primary is shaping the future of our children with a focus on success for all students, high quality teaching and leadership and building school community partnerships.
