The WACHS – Goldfields multidisciplinary palliative care team provides consultation services and some direct patient care across patients' own homes, WACHS hospitals in the region and residential aged care facilities. Specialist services delivered as part of this role may occur in person, through fly-in, fly-out regional visits; telehealth consultations; email and telephone support. The position is expected to work closely with the Director, Palliative Care WACHS in ensuring appropriate governance of regional palliative care services.

- Provide clinical leadership in the provision of comprehensive palliative care services within WACHS Goldfields
- Work closely with the regional palliative care medical officer, local GPs and the regional palliative care team in developing care plans for palliative care patients with complex needs though the provision of specialist advice
- Develop capacity in the regional palliative care team in the delivery of high-quality palliative care

Assist in other team activities across teaching, supervision and quality improvement.
