

# **Brief Summary of Duties (in order of importance)**

#### 1. Clinical Duties

- 1.1 Attends patients admitted into the ICU and patients suffering emergency medical conditions on the wards and in the Emergency Department.
- 1.2 Provides accurate and satisfactory written documentation of each episode of patient management.
- 1.3 Checks investigation results and follows up abnormal results.
- 1.4 Provides a completed discharge summary at the time of patient's discharge from the ICU.
- 1.5 Participates in the site Medcial Emergency Response Team.
- 1.6 Works within a multidisciplinary team to facilitate patient management.
- 1.7 Communicates with patient's next of kin, General Practitioner and Specialist as appropriate.
- 1.8 Participates in the 24/7 departmental roster and participates in on-call.

#### 2. Education / Training / Research

- 2.1 Undertakes on-going professional development to maintain professional and technical skills.
- 2.2 Active involvement in the educational activities of the ICU.
- 2.3 Assists with and participates in staff training and development programs.

#### 3. Quality Assurance / Performance Management

- 3.1 Participate in departmental quality assurance activities and data collection.
- 3.2 Participate in a continuous process to monitor, evaluate and develop own performance.

#### 4. EMHS Governance, Safety and Quality Requirements

- 4.1 Participates in the maintenance of a safe work environment.
- 4.2 Actively participates in the Peak Performance program.
- 4.3 Supports the delivery of safe patient care and the consumers' experience including participation in continuous quality improvement activities in accordance with the requirements of the National Safety and Quality Health Service Standards and other recognised health standards.
- 4.4 Completes mandatory training (including safety and quality training) as relevant to role.
- 4.5 Performs duties in accordance with the EMHS Vision and Values, WA Health Code of Conduct, Occupational Safety and Health legislation, the Disability Services Act and the Equal Opportunity Act and Government, WA Health, EMHS and Departmental / Program specific policies and procedures.

#### 4. Undertakes other duties as directed.

## **Work Related Requirements**

# The following criteria should be read together with the Brief Summary of Duties and considered in the context of the EMHS Values.

#### **Essential Selection Criteria**

- 1. Eligible for registration by the Medical Board of Australia.
- 2. Demonstrated clinical and procedural experience sufficient to undertake the safe care of patients in ICU.
- 3. Demonstrated knowledge of the Australian healthcare system.
- 4. Minimum six months demonstrated critical care experience (ED/ICU/Anaesthesia)
- 5. Demonstrated evidence of completion or enrolment into ALS or equivalent.
- 6. Demonstrated effective communication/interpersonal skills.
- 7. Demonstrated conflict resolution skills.
- 8. Demonstrated experience and ability to work effectively as part of a multidisciplinary team.

#### **Desirable Selection Criteria**

- 1. Possession of or progress towards postgraduate qualifications in a medical speciality relevant to intensive care.
- 2. Demonstrated commitment to research, innovation and quality improvement processes.
- 3. Current knowledge and commitment to Equal Opportunity in all aspects of employment and service delivery.

#### **Appointment Prerequisites**

Appointment is subject to:

- Evidence of registration by the Medical Board of Australia must be provided prior to commencement.
- Completion of 100 Point Identification Check.
- Successful Criminal Record Screening Clearance.
- Successful Pre-Employment Integrity Check.
- Successful Pre-Employment Health Assessment.
