6. Evidence of a current Australian Security Identification card (ASIC).
7. Evidence of a current Dangerous Goods Awareness certificate.
8. Minimum 300 hours Pilot in Command (**Highly Desirable**)

The following essential criteria will be assessed at some stage during the selection process. Desirable criteria will be assessed as required:

9. Understanding of occupational, health and safety, equity and diversity principles and practices.
10. Current 'C' Class Driver's Licence.
11. Experience in aerial fire suppression, detection and reporting operations. (**Desirable**)
