### **Branch Support**

- Provides support and contributes to general business matters relating to the branch operation, such as
  risk management, policy and procedure development, performance reporting and continuous
  improvements to ensure the branch delivers in accordance to PTA requirements.







#### **Technical**

- Provides technical guidance and advice with regard to technical matters such as to designs, drawings
  and documents and represent the branch as a technical expert; providing active leadership in the area
  of safety and participates in incident investigations; identifies, records and appropriately manages
  risks and hazards: reviews the appropriateness of existing risk control; reviews contractor's safety
  management systems and processes and monitor safety performance.
- Contributes technical expertise and knowledge to asset maintenance, testing and commissions, inspecting, reviewing, investigating and identifies appropriate condition monitoring technologies to meet the needs of the branch.
- Participates in the review and development of technical requirements necessary to comply with Legislation, Standards and other external regulations taking account of engineering best practice; and with the development and review of codes of practice, technical standards, specifications, work instructions and good practice guides.
- Contributes to branch asset management requirements, supporting the delivery of renewal programs and projects within the division and for major projects; so that works necessary to deliver PTA goals are identified, specified and achieved.
- Coordinates and liaises with contractors to facilitate the delivery of condition monitoring activities, developing inspection programs ensuring contractors are scheduled without conflict and comply with the PTA's procedures and operational requirements.

- Proven experience in applying safety management systems and knowledge of the Rail Safety Legislation.
- Proven experience in applying asset management frameworks contributing to asset management strategy.
