Key role of this position

Provides engineering support and expertise for the maintenance, design, construction, upgrades and modifications of the Track branch assets; contributing to the overall performance, reliability and compliance of the PTA Track network.

Core duties and responsibilities

Management and Leadership

- As a senior member of the Branch, contributes to both the Branch operational performance and the reliability of assets leading to the effective delivery of services for the PTA.
- Contributes to the branch engagement and performance by providing ideas and opinions for improvement; delivering against Divisional and Branch objectives and management expectations; maintaining and developing technical competence and supporting the development of others.
- Contributes to developing a positive safety culture, providing ideas and opinions for continuous improvement in workplace safety, engineering design and maintenance delivery ensuring works personally carried out comply with PTA requirements and other legislative requirements.
- Provides support and contributes to general business matters relating to the branch operation, such as risk management, policy and procedure development, performance reporting and continuous improvements to ensure the branch delivers in accordance to PTA requirements.

Asset Management

- Provides technical guidance and advice with regard to technical matters such as, designs, drawings and documents and represent the branch as a technical expert.
- Contributes technical expertise and knowledge to engineering, design, maintenance, testing and commissioning, inspecting, testing, reviewing, investigating and any other arrangements necessary to support the operation; carrying out delegated arrangements to achieve business objectives appropriately and to management expectation.







- Participates in the review and development of technical requirements necessary to comply with Legislation, Standards and other external regulations taking account of engineering best practice; and with the development and review of codes of practice, technical standards, specifications, work instructions and good practice guides.
- Contributes to branch asset management requirements; supporting or acting as Coordinating Project
 Engineer and/or Project Engineer to deliver renewal programs and projects within the division and for
 major projects so that works necessary to deliver PTA goals are identified, specified and achieved.

SELECTION CRITERIA

- Proven experience in providing engineering expertise and knowledge in the planning, design, delivery and commissioning of maintenance and/or construction works in a Track systems operational asset intensive environment.
- Proven experience in applying safety management systems and knowledge of the Rail Safety Legislation.
- Proven experience in applying asset management frameworks contributing to asset management strategy.
- Proven ability to develop and interpret standards for the construction of civil and transport related assets.

2. Management and Leadership

 Demonstrated experience in providing leadership to others that contributes to the achievement of agreed outcomes for a team.

3. Communication and Interpersonal

- Sound verbal, written and interpersonal communication skill, including negotiation and facilitation skills.
- Demonstrated ability to write concise and well-structured technical reports.
- · Ability to develop rapport with internal and external stakeholders

4. Conceptual, Analytical and Problem Solving

- Well-developed conceptual and analytical skills.
- Ability to resolve complex technical and operational problems and issues

5. Planning and Organisational

Well-developed organisational skills with the ability to achieve agreed targets and timelines through the

 requirement continues for the duration of employment in this position and from time to time production of
 the licence on request by the PTA may be required.
- Ability to work unsocial hours, callouts, travel and stay away from home station, sometimes at short notice.
