# **Reporting relationships**

### Key role of this position

- Provides electrical engineering support with respect to acquisition, modification and maintenance of the Public Transport Authority's (PTA) rollingstock assets (diesel and electric).
- Uses electrical engineering expertise to assist with management of outsourced rollingstock maintenance contracts.

### Core duties and responsibilities

### Engineering

- Provides engineering support to maintenance teams as required, such as assistance with fault finding and development of repair procedures.
- Oversees rollingstock maintenance and modification activities to ensure that they are carried out in accordance with technical, quality and safety requirements.
- Provides technical input into acquisition of new rollingstock, including preparation of electrical aspects of rollingstock specifications and review of design submissions.
- Investigates, develops and implements continuous improvement in rollingstock, depot, plant, and equipment using a data driven approach focussed on the achievement of business objectives.
- Maintains and develops documentation for PTA rollingstock electrical systems, such as manuals, drawings and spare part specifications.
- Responds to technical queries relating to PTA rollingstock.
- Contributes to the development and implementation of Asset Management Plans for PTA rollingstock.

- Contributes to the development of the PTA's rollingstock and interface standards.
- Provides specialist technical support to Railway Incident Investigations.

## **Contract Management**

- Provides technical support to the Contracts Manager to ensure effective management of contractors and suppliers.
