

1. Program Management

- 1.3. Develops relevant policy, procedure and standards associated with the program.

- 2.4. Coordinates the appropriate reference / control groups', ensuring appropriate group consultation and liaison occurs.
- 2.5. Provides program reports and updates as required, including audit reports, drafting briefing notes and ministerial responses.
- 2.6. Maintains sound documentation and records, including developing required information systems to support program objectives.

To ensure the delivery of quality and safe food services across all sites in accordance with the Nutrition Standards for Adult Inpatients and Residential Aged Care Policy, the Australian and New Zealand Food Standards Code 3.3.1, the Food Safety Program for Food Service to Vulnerable Persons, and other applicable standards.
