Works collaboratively with the Veterinarians and Veterinary Nurses to provide high quality medical care to animal patients, training for undergraduate and postgraduate students, and participates in scientific research.

4. Responsibilities of the Position and Broad Outline of Duties

Animal Health and Welfare

- 1. Provides preventative and reactive veterinary care to zoo animals and native wildlife, including diagnostic, medical, surgical and emergency procedures.
- 2. Investigates disease outbreaks in the zoo and free-ranging wildlife, including carrying out post mortem examinations.
- 3. Assists with the implementation and review of Perth Zoo's quarantine and biosecurity practices, ensuring they are consistent with industry standards and all legislative requirements.
- 4. Considers the welfare of animals in all veterinary decisions and collaborates with Life Sciences staff in evaluating quality of life for animals.
- 5. Contributes veterinary advice regarding species management, captive breeding and contraception in consultation with the Veterinary Manager.
- 6. Ensures animal health records are maintained to a professional standard and meet all organisational and legislative requirements for record keeping.
- 7. Works collaboratively within the clinical team to ensure animal health and welfare practices and procedures are of a consistently high standard across the zoo.
- 8. Contributes to the planning and management of complex animal procedures and clinical cases, in consultation with the Veterinary Manager.
- 9. Collaborates with Life Sciences staff and external stakeholders to share knowledge and provide expert advice regarding zoo and wildlife health issues.
- 10. Monitors animal patients for zoonotic diseases and provides appropriate advice regarding prevention of zoonotic disease transmission to people.

Education, Training and Research

- 11. Delivers training in and assists with review of undergraduate and postgraduate teaching programs in zoo and wildlife medicine, in consultation with Murdoch University course coordinator and the Veterinary Manager.
- 12. Participates in Perth Zoo's research and conservation programs, including fieldwork, as required.
- 13. Provides training to zoo staff in animal health and management issues such as nutrition and preventative health care.

Stakeholder relationships

- 14. Builds and maintains good working relationships with local, national and overseas parties with regard to veterinary, conservation and species management issues.
- 15. Actively promotes collaborative relationships with veterinary and human medical specialists who provide assistance to the Perth Zoo veterinary team.
- 16. Assists with public relations activities and undertakes media interviews and presentations as required.

Other

- 17. Contributes productively to a team culture where staff are respected and valued, and work is consistently performed to a high standard, thus supporting a positive and fulfilling work environment.
- 18. Provides leadership to zoo staff in clinical situations.
- 19. Undertakes other duties as directed.

5. Selection Criteria In the context of the duties and responsibilities of the position, the following selection criteria apply. All criteria are essential unless specified otherwise.

Applicants should address the following nine essential criteria in a written application. These should be addressed in no more than two pages in total.

- 1. Significant demonstrated knowledge and experience in the provision of veterinary care for wild animals in a zoo or similar environment, including husbandry, management, medicine, surgery, disease investigation and chemical restraint of a range of Australian and exotic species.
- 2. Demonstrated planning and organisational skills including the ability to manage priority conflicts and arrange work routines to make optimum use of time and resources.
- 3. Excellent written and verbal communication skills, including proven ability to establish effective working relationships with other veterinary and animal keeping staff, and external contacts.

The following essential criteria will be assessed at some stage during the selection process. Desirable criteria will be assessed as required:

- 4. A Veterinary degree qualification, eligible for registration by the WA Veterinary Surgeons Board to practice veterinary medicine in Western Australia.
- 5. Possession of, or eligibility to obtain, a permit to operate a dart gun (firearm) in Western Australia.
- 6. Current Class C Driver's License (or equivalent).
- 7. Sound understanding of research and/or conservation programs and projects related to Perth Zoo's objectives.

Desirable criteria:

- 8. Board certification by the European or American College of Zoological Medicine or equivalent, or other postgraduate training in wildlife health.
- 9. Experience in training and/or supervising undergraduate and/or postgraduate students.
