#### Key role of this position

Provides technical support and permanent way design and drafting expertise in electronic formats for the planning design and operational requirements of railway infrastructure. This position also maintains the drawing inventory in accordance with the Public Transport Authority's (PTA) Standards.

### Core duties and responsibilities

- Develops and undertakes rail infrastructure modelling utilising specialist software and drawings. Key areas of model construction include:
  - Build network infrastructure (track, signals, stations, electrical infrastructure).
  - Add rollingstock models.
  - Develop 3D models.
- Processes rail 3D modelling data and advise on planning and design of rail infrastructure.

- Maintains accurate records of input and output data and assumptions made when developing infrastructure models.
- Analyses and interprets input and output data, and produces reports detailing methodologies, assumptions, conclusions and recommendations.
- Provides technical support and design solutions in electronic formats for the planning and design of railway infrastructure.
- Undertakes the design of railway infrastructure in accordance with relevant standards and Codes of Practice, in an electronic format.
- Maintains Asset, Drawing and Design Data Bases in association with others (such as document controllers), in accordance with relevant standards.
- Liaises with internal and external parties such as surveyors and other professional and technical staff in the execution of the duties of this position.

- Articulates and specifies technical requirements for railway infrastructure survey pick up, setting out, design and construction.
- Maintains currency of electronic drawing practices and standards.
- Validates that works that have been set out, or are under construction, are in accordance with design drawings and assumptions.

• Well developed mathematical and problem solving skills.

• Sound organisational skills, including ability to meet deadlines and be self-reliant.

## 5. Computer Literacy

- Experience in the use of Computer Aided Drafting technology.
- Experience in the use of current AutoCAD design package or equivalent
- Experience in the use of 12D computer design packages or equivalent.

- Satisfactory completion of required medical examinations to verify physical fitness to perform the duties of the position.
