



KEY RESPONSIBILITIES

Under limited supervision, this position is responsible for evaluating toxicological data and develops and implements suitable strategies for managing contaminated land /air quality for the Department of Health (DOH). Develops draft policy on contaminated land /air quality as required. Provides expert technical support and advice on hazardous substances to the Managing Scientist Chemical Hazards, the Executive Director Environmental Health, the Executive and other professionals in the division.

BRIEF SUMMARY OF DUTIES

This section outlines the results and outcomes required of an individual in this position.

Employees are required to undertake all duties and responsibilities in accordance with Department of Health WA Code of Conduct, Policies/Procedures and relevant legislation.

- 1. Develops and implements suitable strategies for managing contaminated land/ air quality for the DOH.
- 2. Develops draft policy on contaminated land /air quality as required.
- 3. Contributes to the setting and achievement of sectional objectives.
- 4. Provides expert technical support and advice on hazardous substances to the Principal Toxicologist, Managing Scientist, Environmental Health Hazards, the Director, Environmental Health, the Executive and other professionals.
- 5. Evaluates scientific data and carries out health risk assessments on chemicals of public health importance with respect to contaminated land/ air quality and advises on its management.
- 6. Contributes to the development of chemical standards at State and national levels.
- 7. Provides advice to other organisations (including government departments) and the public as required.
- 8. Researches, prepares and follows up responses to ministerial correspondence.
- 9. Prepares and delivers lectures, attends and participates in meetings, both scientific and committee, as directed.
- 10. Produces educational material (e.g. Pamphlets, guidelines) on, contaminated land /air quality and hazardous substances.
- 11. Performs other duties as directed.

- 4. Considerable experience in the management of environmental health issues relating to contaminated land /air quality.
- 5. Ability to work effectively as a team member and as required work independently to ensure work tasks are delivered reliably and on time
- 6. Excellent interpersonal, verbal and written communication skills, including letter and report writing skills.

- 1. Knowledge of appropriate health and environmental legislation.
- 2. Current knowledge and commitment to Equal Opportunity in all aspects of employment and service delivery.
