The directorate also provides specialist inspectors who work across industry in relation to plant, engineering, human factors, ergonomics and occupational hygiene Role Overview

This position will carry out routine inspections undertaking the enforcement of WHS law with the support of a team of inspectors.

- Carry out workplace inspections and take enforcement action when health and safety laws are breached. .
- Investigate lower complexity workplace incidents. Assist in gathering evidence and making recommendations about prosecutions
- Promote Work Health and Safety, deliver presentations and provide information to workplaces to contribute towards implementation of good practice.
- Liaise with client groups including employers, employees, government, unions and industry organisations.
- Participate in team projects and have input to future policy/direction and facilitate continuous improvement.
- Contribute to sustaining a positive team culture.
- Undertake occasional travel, work in remote areas and occasionally work outside normal business hours as required.
- Undertake other duties as directed that fall within the scope of the position.
