Section 1. Date of Birth

Date of Birth in full numeric form ie 1 February 2000 should be written 01/02/2000.

Section 2. Residential Address

Residential Address is where you currently reside either in Australia or overseas. Do not use a postal address or that of a family or friend unless you currently reside at that address.

Section 3. Living interstate/overseas

If answered YES to this question, please list all addresses.

Section 4. Name Changes

Please detail any and all changes to your name since that shown on your birth certificate. Include any "Known As" or "Nick", "Stage", and "Pen" names you are or have been known by. Include names changes resulting from partnerships whether it was legally changes and even if you no longer are known by this name. Include changes to either Last/Family Names and/or Given Names.

Section 5. Convictions

These are as a result of court action whereby you were found guilty and/or charge is currently pending resolution by court action. These include ALL convictions including those that have been declared as Spent. Please refer to the Spent Convictions Act 1988. This includes any driving convictions or suspension of driver's licence through the loss of demerit points. Please note that a criminal record does not necessarily disqualify you as an applicant. Details provided should include the type of offence and the date it occurred. Remember, if you were not convicted, you do not need to include it in this section.
