Provides basic education to patients under the direction of a dietitian. Works as a member of a multi-disciplinary team.

About our health service

The Child and Adolescent Health Service (CAHS) is a comprehensive service that supports and treats children from around Western Australia, and is committed to programs that promote lifelong health in children and adolescents.

CAHS is made up of four service streams:

- **Neonatology:** Neonatology provides state-wide tertiary neonatal services to the sickest newborn babies and infants in Western Australia.
- Community Health: a comprehensive range of community based early identification and intervention services, as well as health promotion, to children and families in the Perth metropolitan area. Services are provided in a variety of settings including at home, local community health centres, child and parent centres and schools.
- Child and Adolescent Mental Health Services (CAMHS): provide mental health services to infants, children, young people and their families across the Perth metropolitan area. Services include community based programs, inpatient care at Perth Children's Hospital and specialised services for children with complex mental health conditions across the State.
- Perth Children's Hospital (PCH): is the specialist State-wide paediatric hospital and trauma centre for Western Australia, caring for children up to the age of 16. PCH is also a centre of excellence for teaching and research, partnering in major paediatric research and education initiatives led by the Telethon Kids Institute (TKI) and the State's universities.

Summary of accountabilities

1. Clinical (under the direction and supervision of a Dietitian).

- Under the direction of a dietitian, coordinates the ordering of therapeutic diets for inpatients.
- Liaises with dietitians, patients, parents / carers, food services staff and nursing staff regarding individual meal preferences within special dietary requirements.
- Creates individualised meal orders for inpatients based on therapeutic dietary requirements.
- Prepares therapeutic diet and allergy lists from menu software for Dietitians.
- Liaises with food service staff regarding ingredients used in recipes.
- Liaises with food service staff regarding adequate stock of food items for therapeutic diets.
- Participates in quality improvement activities related to the provision of special diets.
- Aware of, and applies, principles of Hazard Analysis Critical Control Points (HACCP).
- Takes details regarding food allergies from inpatients admitted to the Emergency Department and wards to ensure allergies are accurately recorded in software systems.
- Documents provision of special diets in medical records.
- Measures height and weight and plots on growth charts for patients.
- Calculates percentage weight change of patients, under the direction of a dietitian.
- Assists Senior Dietitian responsible for food service with menu software updates and reporting. Cross checks allergy meal ingredients for compliancy & accuracy.
- Undertakes shifts at the direction of the HOD Dietetics and Coordinator Dietetics, including participation on the weekend roster where required.

2. Management

- Participate in staff meetings.
- Prepare and maintain resources and equipment in collaboration with clinical staff.
- Records daily workload statistics in Allied Health Statistics (AHS)
- Participates in performance development with line manager.
- Participate in appropriate professional development activities.
- Participate in Quality Improvement Activities.
- Undertakes other duties within the level, knowledge and expertise, as directed.
- Assists in the provision of urgent feed orders in the absence of the nutritional feeds officer.

3. Educational

- Provides in-services to food services staff regarding special diet orders.
- Gives basic nutritional and/or dietary instructions to patients / parents / carers, as directed.

4. CAHS governance, integrity, safety and quality requirements
