

## **Key Duties/Responsibilities**

#### 1. CLINICAL

- 1.1. Provides inpatient care for patients in accordance with scope of practice (geriatric and general medicine) in compliance with WA Health Department and WACHS policies as applicable.
- 1.2. Undertakes geriatric and general medical outpatient and Telehealth clinics at Albany Health Campus and regional outreach clinics, as required. Ensures patients are triaged within 5 days of receiving referrals.
- 1.3. Ensures patient medical records are maintained in accordance with established protocols.
- 1.4. Provides clinical leadership to inpatient subacute, outpatient subacute, allied health, nursing and junior medical staff..
- 1.5. Consults and liaises with acute services (intra and inter hospital referrals) to manage patient flow through subacute care into community.
- 1.6. Ensures that all written correspondence is timely; discharge summary on day of discharge and clinic letters within 7 days.
- 1.7. Contributes to reviews of deaths occurring in hospital patients and clinical audit, as required.
- 1.8 Participates in an on-call roster as required, including weekends.

#### 2. ADMINISTRATION AND MANAGEMENT

- 2.1. Participates in the development of evolving models of care in medical practice at Albany Health Campus and the Great Southern.
- 2.2. Contributes to clinical governance including the continuous improvement of patient safety and care quality.
- 2.3. Leads Subacute ward governance coordinating resources and managing patient flow.
- 2.4. Participates in Internal Medicine Business and Clinical Review Meetings for integrated clinical service delivery.
- 2.5. Participates in the Clinical Incident Meetings and Monitoring investigation system as required.
- 2.6. Attends to medico legal matters arising in the Geriatric care services.

#### 3. EDUCATION

- 3.1. Supports, educates and supervises all levels of junior medical staff assigned to the cover of their patients.
- 3.2. Contributes to undergraduate and postgraduate teaching.
- 3.3. Participates in annual written performance appraisals
- 3.4. Completes Mandatory Training as required and maintains up to date CPD.
- 3.5. Maintains a working knowledge of contemporary geriatric and medical treatments and standards including ethical standards applied to medical practice by means of background reading and attendance at relevant meetings and workshops.

#### 4. LEADERSHIP

- 4.1. Participates in the orientation of new members of the Department.
- 4.2. Provides strategic direction for Geriatric medicine across the Great Southern region.
- 4.3. Participates in programs to ensure safety and quality of services including audit, incident review and clinical practice improvement projects.
- 4.4. Advises the Regional Medical Director in collaboration with the Aged and Subacute Care Manager on Geriatric and Subacute Services related matters.

5.1. Other duties consistent with their role as directed by the line manager.
