Position	Bachelor degree to be completed in 2021, 2022 or 2023.
Graduate Officer – Cyber Security	Bachelor of Science degree in Cyber Security or an approved equivalent.
Graduate Officer – Data Science	Bachelor degree in Data Science, Analytics, Visualisation or an approved equivalent.
Graduate Officer – Energy Demand Initiatives	Bachelor degree in Arts, Economics, Commerce, Law, Science or an approved equivalent.
Graduate Officer – Government Trading Enterprises	Bachelor degree in Arts, Business, Communications, Commerce, Community Development, Finance, Politics, Science, Law, Environment, Energy, Sustainability or an approved equivalent.

Graduate Officer – Policy Analyst	Bachelor degree in Engineering, Economics, Law or an approved equivalent.
Graduate Officer – Strategic Energy Policy	Bachelor degree in Law, Sustainability, Science, Environment, Engineering, Economics, Commerce or Arts (Geography) or an approved equivalent.

Position	Bachelor degree to be completed in 2021, 2022 or 2023.
Graduate Officer – Building Codes and Standards	Bachelor degree in Building Surveying, Architecture, Structural Engineering, Construction Management or similar with a focus on technical building standards.
Graduate Officer – Building Compliance	Bachelor degree in Law, Media, Communications, Public Policy, Arts or an approved equivalent.
Graduate Officer – Legislation and Policy	Bachelor degree in one of the following fields of an appropriate equivalent: Social Sciences, Commerce, Economics or Law.
Graduate Officer – Licensing Services	Bachelor degree in Commerce, Law, Public Policy, Arts, Humanities, Social Sciences or an approved equivalent.

Position	Bachelor degree to be completed in 2021, 2022 or 2023.
Graduate Officer – Environmental Officer	Bachelor degree in Environmental Science, Natural Resource Management or an approved equivalent.
Graduate Officer – Major Resource Projects	Bachelor degree in Arts, Law, Commerce, Economics, Public Policy, International Relations or an approved equivalent.
Graduate Officer – Resource Strategy	Bachelor degree in Economics, Commerce or an approved equivalent such as Bachelor of Arts majoring in Economics or Commerce.

Position	Bachelor degree to be completed in 2021, 2022 or 2023.
Graduate Officer – Mines Safety Mental Health and Wellbeing	A Bachelor of Science or other approved Bachelor degree in a relevant Work Health and Safety discipline related to Psychosocial, Social Work or Counselling, such as Bachelor of Psychological Science or Bachelor of Psychology and Counselling.
Graduate Officer – Regulatory Support	Bachelor degree in Communications or an approved equivalent Bachelor degree with a Communications focus.
