# **Job Description**

At this level a solicitor will have significant experience in legal practice and provide advice and representation at a senior level. A solicitor at this level is required to provide complex legal advice and representation on complex legal matters, particularly casework. This includes dealing with matters within a specialised area of law, for example social security law and administrative law. The solicitor will also provide specialist advice and leadership in regards to complex legal matters.

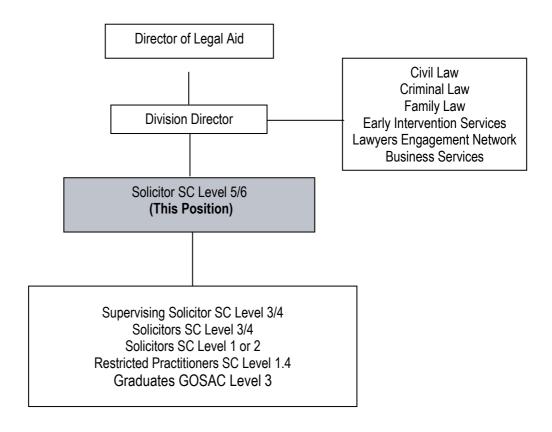

## **Scope of Duties**

- Provision of legal advice and supervision of complex casework including superior court trial and appellate work.
- Provides advice on matters of factual and legal difficulty including on complex points of the law, trial and appellate issues.
- Provides significant legal and administrative decisions/judgments such as decisions at each stage of the litigation process; tactical decisions during trials/pleas in mitigation; tactical decisions in regard to trial strategy.
- Significant liaison and negotiation on matters of complexity.
- Provision of supervision and guidance to junior practitioners. Acts as mentor where applicable.
- High level of initiative and judgment in the performance of the role.
- Drafts complex legal documents.
- Works cooperatively in a team environment, contributes to team goals and creates and fosters a motivating climate for the team's effectiveness.
- Works unsupervised on day to day activities.
- Manages and/or supervises the work of a designated team.

### Selection Criteria

Only the criteria in bold must be addressed in applicant's written application and resume. These and the remaining selection criteria will be assessed through interview or alternative selection methods.

### **ESSENTIAL**

- Extensive post admission experience.
- Substantial advocacy and trial experience.
- High level negotiation skills.
